General remarks and official action taken:

This is a default order taken against Shawn Jean (Respondent) because he does not hold a license in good standing as an agent in his home state of residence and did not notify the Texas Department of Insurance of the administrative action taken against him. Respondent did not respond to a Notice of Hearing filed by the Texas Department of Insurance. This order revokes Respondent's license.

The following findings of fact and conclusions of law are adopted:

Findings of Fact

Failure to Respond to Notice of Hearing

- 1. On June 8, 2021, the department filed a Notice of Hearing, attached as Exhibit A, and an Original Petition, attached as Exhibit B, with the State Office of Administrative Hearings.
- 2. On June 29, 2021, the department filed an Amended Notice of Hearing, attached as Exhibit C, and an Amended Petition, attached as Exhibit D, with the State Office of Administrative Hearings.

- 3. The department's factual allegations set out in the attached Amended Notice of Hearing and Amended Petition are incorporated in this order as findings of fact.
- 4. The department sent the Notice of Hearing, Amended Notice of Hearing, Original Petition, and Amended Petition to Respondent's last known address provided in writing to the department, Miami Gardens, Florida 33056. The Notice of Hearing, Amended Notice of Hearing, Original Petition, and Amended Petition were also sent by electronic mail and to two additional addresses associated with Respondent: Miami, Florida 33147 and Miramar, Florida 33025.
- 5. Respondent failed to file a written response to the Notice of Hearing within 20 days of the date the Notice of Hearing and Original Petition were mailed. Respondent also failed to file a written response to the Amended Notice of Hearing within 20 days of the date the Amended Notice of Hearing and Amended Petition were mailed.

Conclusions of Law

- 1. The commissioner has jurisdiction over this matter pursuant to Tex. Ins. Code §§ 82.051-82.055, 84.021–84.022, 4001.002, 4001.252, 4005.101, 4005.102, 4054.051, and 4056.052, and Tex. Gov'T Code §§ 2001.051-2001.178.
- 2. The commissioner has authority to dispose of this case informally under Tex. Gov'T CODE § 2001.056; Tex. Ins. CODE § 82.055; and 28 Tex. ADMIN. CODE §§ 1.47, 1.88, and 1.89.
- 3. The department provided proper notice of the hearing under Tex. Gov't Code §§ 2001.051, 2001.052, and 2001.054, and 28 Tex. Admin. Code §§ 1.28, 1.88, 1.89, and 19.906.
- 4. Based on Respondent's failure to file a written response to the Notice of Hearing, the department is entitled to disposition by default under 28 Tex. ADMIN. CODE §§ 1.88 and 1.89.
- 5. The department's factual and legal allegations set out in the attached Amended Notice of Hearing and Amended Petition are incorporated in this order and deemed admitted as true under 28 Tex. ADMIN. CODE § 1.89.

Jurisdiction

The Commissioner of Insurance has jurisdiction over this matter pursuant to Tex. Ins. CODE §§ 82.051-82.055, 84.021–84.022, 4001.002, 4001.252, 4005.101, 4005.102, 4054.051, and 4056.052, and Tex. Gov't Code §§ 2001.051-2001.178.

Factual Allegations

Licensure

- 1. Shawn Jean (Jean), individual identification number 18571275, holds a non-resident general lines agent license with a life, accident, and health qualification, originally issued by the Texas Department of Insurance on October 17, 2017.
- 2. Jean has a Texas non-resident license because he lives in Florida. This license type requires that Jean have a resident license in good standing in his home state.
- 3. On December 30, 2020, the Florida Department of Insurance revoked Jean's resident insurance agent license. Jean did not notify TDI of the revocation.

4. Indiana also took administrative action against Jean. Jean also did not notify TDI of that administrative action.

Legal Allegations

- 1. Jean does not hold a license in good standing as an agent in his home state of residence, as required by Tex. INS. CODE § 4056.052, and is no longer eligible to hold a non-resident license in Texas.
- 2. Jean did not notify TDI of the administrative actions taken against him, in violation of Tex. INS. CODE § 4001.252.

Relief Sought

If one or more of the above allegations is found to be true, the department asks the Administrative Law Judge to enter a Proposal for Decision recommending that the Commissioner of Insurance issue an order:

- 1. revoking Jean's license;
- 2. directing Jean to pay an administrative penalty under Tex. INS. CODE §§ 84.021–84.022; and
- 3. any other just and appropriate relief to which the Department may be entitled to by law, including any combination of the above actions.

- 1. Shawn Jean (Jean), individual identification number 18571275, holds a non-resident general lines agent license with a life, accident, and health qualification, originally issued by the Texas Department of Insurance on October 17, 2017.
- 2. Jean has a Texas non-resident license because he lives in Florida. This license type requires that Jean have a resident license in good standing in his home state.
- 3. On December 30, 2020, the Florida Department of Insurance revoked Jean's resident insurance agent license. Jean did not notify TDI of the revocation.

Indiana also took administrative action against Jean. Jean also did not notify TDI
of that administrative action.

Legal Allegations

- 1. Jean does not hold a license in good standing as an agent in his home state of residence, as required by Tex. INS. CODE § 4056.052, and is no longer eligible to hold a non-resident license in Texas.
- 2. Jean did not notify TDI of the administrative actions taken against him, in violation of Tex. INS. CODE § 4001.252.

Relief Sought

If one or more of the above allegations is found to be true, the department asks the Administrative Law Judge to enter a Proposal for Decision recommending that the Commissioner of Insurance issue an order:

- 1. revoking Jean's license;
- 2. directing Jean to pay an administrative penalty under Tex. INS. CODE §§ 84.021–84.022; and
- 3. any other just and appropriate relief to which the Department may be entitled to by law, including any combination of the above actions.
