General remarks and official action taken:

The subject of this default order is whether an adjuster all lines license should be issued to Theresa Irene Reyes (Respondent). Respondent did not respond to a Notice of Hearing filed by the Texas Department of Insurance. This order denies Respondent's license application.

The following findings of fact and conclusions of law are adopted:

Findings of Fact

- 2. The department's factual allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order as findings of fact.
- 3. The department sent the Notice of Hearing and Original Petition to Respondent's last known address provided in writing to the department, TX 79930, and to the electronic mail address on file with the department.

4. Respondent failed to file a written response to the Notice of Hearing within 20 days of the date the Notice of Hearing and Original Petition were mailed.

- 2. The commissioner has authority to dispose of this case informally pursuant to Tex. GOV'T CODE § 2001.056; Tex. Ins. Code § 82.055; and 28 Tex. Admin. Code §§ 1.47, 1.88, and 1.89.
- 3. The department provided proper notice of the hearing pursuant to Tex. GOV'T CODE §§ 2001.051, 2001.052, and 2001.054, and 28 Tex. ADMIN. CODE §§ 1.28, 1.88, 1.89, and 19.906.
- 4. Based on Respondent's failure to file a written response to the Notice of Hearing, the department is entitled to disposition by default pursuant to 28 Tex. ADMIN. CODE §§ 1.88 and 1.89.
- 5. The department's factual and legal allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order and deemed admitted as true pursuant to 28 Tex. Admin. Code § 1.89.

ORIGINAL PETITION

The Texas Department of Insurance seeks to deny Theresa Irene Reyes's license application. In support of this petition, the department makes the following allegations upon information and belief:

Jurisdiction

The Commissioner of Insurance has jurisdiction over this matter pursuant to Tex. Ins. Code §§ 82.051-82.055, 4001.002, 4005.101, 4005.102, 4101.051, and Tex. Gov't Code §§ 2001.051-2001.178.

Factual Allegations

<u>Application</u>

- 1. Theresa Irene Reyes (Reyes) applied for an adjuster all lines license with the Texas Department of Insurance (TDI) on September 22, 2020.
- 2. On September 30, 2020, TDI proposed to deny the license based on Reyes's prior conduct in the banking industry and subsequent Financial Industry Regulatory Authority (FINRA) disciplinary action.
- 3. On October 21, 2020, TDI received Reyes's request for a hearing on this matter.

FINRA Disciplinary Action

- 4. On February 20, 2013, Reyes was permanently barred from the securities industry in FINRA disciplinary proceeding no. 2011030672401, under Order No. 5544722.
- 5. Order No. 5544722 included the following "Findings and Conclusions":
 - Between August 2011 and October 2011, Reyes repeatedly used her capacity as a private banker at JPMorgan to use a customer's business credit card without the customer's knowledge or authorization.
 - On August 4, 2011, Reyes arranged for her husband to be added as an authorized user on the customer's credit card account and requested a card be issued in her husband's name and sent to her address.
 - On September 12, 2011, Reyes requested and received a credit increase on the customer's credit card account through JPMorgan customer service.
 - On October 19, 2011, Reyes discovered her husband's name was removed from the account after the card was declined and added his name again as an authorized user, as well as requesting another card to be issued in her husband's name, this time to be sent to her branch location.
 - Between August 4, 2011, and October 22, 2011, Reyes and her husband used the cards over 200 times to incur personal charges totaling over \$15,000 without the customer's authorization.
 - Reyes violated FINRA rules to appear for testimony following multiple notices that were received by Reyes.

Legal Allegation

1. Reyes committed acts that allow the department to deny a license application under Tex. Ins. Code § 4005.101(b)(5).

Relief Sought

If the above allegation is found to be true, the department asks the Administrative Law Judge to enter a Proposal for Decision recommending that the Commissioner of Insurance issue an order:

- 1. denying Theresa Irene Reyes's license application and
- 2. imposing any other just and appropriate relief to which the department may be entitled to by law.
