General remarks and official action taken:

This is a default order taken against Kristen Elizabeth Rogers (Respondent) for fraudulent or dishonest conduct. Respondent did not appear at the hearing on the merits. This order revokes Respondent's license.

The following findings of fact and conclusions of law are adopted:

Findings of Fact

Failure to Appear at Hearing on the Merits

- 1. On January 25, 2021, the department filed a Notice of Hearing, attached as Exhibit A, and an Original Petition, attached as Exhibit B, with the State Office of Administrative Hearings.
- 2. The department's factual allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order as findings of fact.
- 3. The department sent the Notice of Hearing and Original Petition to Respondent's last known address provided in writing to the department,

 Birmingham, Alabama 35209. The Notice of Hearing and Original Petition also were sent by electronic mail to an address associated with Respondent.

4. After receiving proper notice of the date, time, and location of the hearing on the merits, Respondent failed to appear for the hearing on October 20, 2021, as shown in the record in SOAH Docket No. 454-21-1148.

Conclusions of Law

- 1. The commissioner has jurisdiction pursuant to Texas law, including Tex. INS. CODE §§ 82.051–82.055, 4001.002, 4005.101, and 4054.051; and Tex. Gov't Code §§ 2001.051–2001.178.
- 2. The commissioner has authority to dispose of this case informally pursuant to Tex. GOV'T CODE § 2001.056; Tex. Ins. CODE § 82.055; and 28 Tex. ADMIN. CODE §§ 1.47, 1.88, and 1.89.
- 3. The department provided proper notice of the hearing pursuant to Tex. Gov'T Code §§ 2001.051, 2001.052, and 2001.054, and 28 Tex. ADMIN. Code §§ 1.28, 1.88, 1.89, and 19.906.
- 4. Based on Respondent's failure to appear in person or by legal representative at the hearing, the department is entitled to disposition by default pursuant to 28 Tex. ADMIN. CODE §§ 1.88 and 1.89.
- 5. The department's factual and legal allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order and deemed admitted as true pursuant to 28 Tex. Admin. Code § 1.89.

Order

It is ordered that any licenses held by Kristen Elizabeth Rogers are revoked. A copy of this order will be provided to law enforcement or other appropriate administrative agencies for further investigation as may be warranted.

ORIGINAL PETITION

The Texas Department of Insurance seeks to take disciplinary action against Kristen Elizabeth Rogers ("Rogers") and Senior Care Services, LLC. In support of this petition, the department makes the following allegations upon information and belief:

Jurisdiction

The Commissioner of Insurance has jurisdiction over this matter pursuant to Tex. Ins. Code §§ 82.051–82.055, 4001.002, 4005.101, and 4054.051, and Tex. Gov't Code §§ 2001.051–2001.178.

Factual Allegations

- 1. Rogers holds a general lines agent license issued by TDI.
- 2. Rogers does business through an Alabama-domiciled entity, Senior Care Services, LLC, which holds a general lines agency license issued by TDI.
- 3. Rogers was appointed by UnitedHealthcare to sell Medicare Advantage plans beginning August 7, 2018.
- 4. After receiving complaints and identifying a suspicious enrollment pattern, UnitedHealthcare canceled Rogers's appointment and reported the cancelation as required per Texas Insurance Code section 4001.206.

- 5. Rogers submitted to UnitedHealthcare a high volume of applications during a short timeframe around September and October 2018. The applicants had previously been UnitedHealthcare members whose plans terminated without renewal about a month previously. UnitedHealthcare received notification that the consumers had moved their coverage to another insurance plan. These consumers then purportedly made application to UnitedHealthcare to begin coverage having been enrolled in the other plan for only one month.
- 6. The applicants did not sign the applications Rogers sent to UnitedHealthcare, and did not consent or authorize Rogers to do so for them.
- 7. Rogers also was appointed, beginning in October 2017, to sell Humana Insurance Company Medicare Advantage products.
- 8. In early 2019, Humana identified a disenrollment/re- enrollment pattern associated with Rogers similar to the one identified by UnitedHealthcare.
- 9. Rogers submitted to Humana a high volume of applications during a short timeframe around February 2019. The applicants had previously been Humana members whose plans terminated without renewal about a month previously. Humana received notification that the consumers had moved their coverage to another insurance plan. These consumers then purportedly made application to Humana to begin coverage having purportedly been enrolled in the other plan for only one month.
- 10. The applicants did not sign the applications Rogers sent to Humana, and did not consent or authorize Rogers to do so for them.

Legal Allegations

- 1. Rogers has engaged in fraudulent or dishonest acts or practices, as contemplated by Tex. Ins. Code § 4005.101(b)(5).
- 2. Senior Care Services, LLC has engaged in fraudulent or dishonest acts or practices, as contemplated by Tex. INS. CODE § 4005.101(b)(5).

Relief Sought

If these allegations are proved, the Commissioner of Insurance is authorized to revoke both the general lines agent license issued to Kristen Elizabeth Rogers per Tex. Ins. Code §§ 82.051 and 4005.101; additionally, the Commissioner is authorized to impose other disciplinary measures per Tex. Ins. Code §§ 82.052–82.055.

If these allegations are proved, the Commissioner of Insurance is authorized to revoke both the general lines agent license issued to Senior Care Services, LLC per Tex. Ins. Code §§ 82.051 and 4005.101; additionally, the Commissioner is authorized to impose other disciplinary measures per Tex. Ins. Code §§ 82.052–82.055.
