General remarks and official action taken:

This is a default order taken against Desiree Diaz (Respondent) because her Nevada resident license was revoked. Respondent did not respond to a Notice of Hearing filed by the Texas Department of Insurance. This order revokes Respondent's license.

The following findings of fact and conclusions of law are adopted:


Findings of Fact

Failure to Respond to Notice of Hearing

- On September 30, 2021, the department filed a Notice of Hearing, attached as Exhibit A, and an Original Petition, attached as Exhibit B, with the State Office of Administrative Hearings.
- 2. The department's factual allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order as findings of fact.
- 3. The department sent the Notice of Hearing and Original Petition to Respondent's last known address provided in writing to the department,

4. Respondent failed to file a written response to the Notice of Hearing within 20 days of the date the Notice of Hearing and Original Petition were mailed.

Conclusions of Law

- 1. The commissioner has jurisdiction under Texas law, including Tex. INS. CODE §§ 82.051-82.055, 84.021-84.022, 4001.002, 4001.252, 4005.101, 4005.102, 4054.301, and 4056.052; and Tex. Gov'T CODE §§ 2001.051-2001.178.
- 2. The commissioner has authority to dispose of this case informally under Tex. Gov'T CODE § 2001.056; Tex. Ins. Code § 82.055; and 28 Tex. Admin. Code §§ 1.47, 1.88, and 1.89.
- 3. The department provided proper notice of the hearing under Tex. GOV'T CODE §§ 2001.051, 2001.052, and 2001.054; and 28 Tex. ADMIN. CODE §§ 1.28, 1.88, 1.89, and 19.906.
- 4. Based on Respondent's failure to file a written response to the Notice of Hearing, the department is entitled to disposition by default under 28 Tex. ADMIN. CODE §§ 1.88 and 1.89.
- 5. The department's factual and legal allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order and deemed admitted as true under 28 Tex. ADMIN. CODE § 1.89.

Jurisdiction

The Commissioner of Insurance has jurisdiction over this matter under Tex. INS. CODE §§ 82.051-82.055, 84.021-84.022, 4001.002, 4001.252, 4005.101, 4005.102, 4054.301, and 4056.052; and Tex. Gov't Code §§ 2001.051-2001.178.

Factual Allegations

Licensure

- 1. Desiree Diaz (Diaz) holds a non-resident life agent license, originally issued by the Texas Department of Insurance on April 7, 2021.
- Diaz has a Texas non-resident license because she lives in Nevada. This license 2. type requires that Diaz have a resident license in good standing in her home state.
- On June 9, 2021, the Nevada Division of Insurance revoked Diaz's license. Diaz 3. failed to notify TDI of her license revocation.

Original Petition Desiree Diaz Page 2 of 2

Legal Allegations

1. Diaz does not hold a license in good standing as an agent in her home state of residence, as required by Tex. Ins. Code § 4056.052, and is no longer eligible to hold a non-resident license in Texas.

Relief Sought

If one or more of the above allegations is found to be true, the department asks the Administrative Law Judge to enter a Proposal for Decision recommending that the Commissioner of Insurance issue an order:

- 1. revoking Desiree Diaz's license and
- 2. imposing any other just and appropriate relief to which the department may be entitled to by law.
