## General remarks and official action taken:

This is a default order taken against Jessica Evette Cadena (Respondent) because she fraudulently converted \$2,299.60 of customer premiums to her own personal use. Respondent did not respond to a Notice of Hearing filed by the Texas Department of Insurance. This order revokes Respondent's license and directs her to make complete restitution to American National Insurance Company in the amount of \$2,299.60.

The following findings of fact and conclusions of law are adopted:

## **Findings of Fact**

## Failure to Respond to Notice of Hearing

- On January 27, 2022, the department filed a Notice of Hearing, attached as Exhibit
   A, and an Original Petition, attached as Exhibit B, with the State Office of
   Administrative Hearings.
- 2. The department's factual allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order as findings of fact.

- 3. The department sent the Notice of Hearing and Original Petition to Respondent's last known address provided in writing to the department, Austin, Texas 78702. The Notice of Hearing and Original Petition were also sent by electronic mail.
- 4. Respondent failed to file a written response to the Notice of Hearing within 20 days of the date the Notice of Hearing and Original Petition were mailed.

## **Conclusions of Law**

- 1. The commissioner has jurisdiction under Texas law, including Tex. Ins. Code §§ 82.051-82.055, 4001.002, 4005.101, 4005.102, and 4054.051; 28 Tex. ADMIN. Code § 1.502; Tex. Occ. Code §§ 53.021–53.023; and Tex. Gov't Code §§ 2001.051-2001.178.
- 2. The commissioner has authority to dispose of this case informally under Tex. Gov'T CODE § 2001.056; Tex. Ins. CODE § 82.055; and 28 Tex. ADMIN. CODE §§ 1.47, 1.88, and 1.89.
- 3. The department provided proper notice of the hearing under Tex. GOV'T CODE §§ 2001.051, 2001.052, and 2001.054, and 28 Tex. ADMIN. CODE §§ 1.28, 1.88, 1.89, and 19.906.
- 4. Based on Respondent's failure to file a written response to the Notice of Hearing, the department is entitled to disposition by default under 28 Tex. ADMIN. CODE §§ 1.88 and 1.89.
- 5. The department's factual and legal allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order and deemed admitted as true under 28 Tex. ADMIN. CODE § 1.89.

## **Order**

It is ordered that any licenses held by Jessica Evette Cadena are revoked. A copy of this order will be provided to law enforcement or other appropriate administrative agencies for further investigation as may be warranted.

It is further ordered that Jessica Evette Cadena must pay restitution to American National Insurance Company in the amount of \$2,299.60. Proof of payment of the restitution must be sent electronically to the department within 30 days of the date of this order to EnforcementReports@tdi.texas.gov.



#### ORIGINAL PETITION

The Texas Department of Insurance seeks to take disciplinary action against Jessica Evette Cadena. In support of this petition, the department makes the following allegations upon information and belief:

## Jurisdiction

The Commissioner of Insurance has jurisdiction over this matter under TEX. INS. CODE §§ 82.051-82.055, 4001.002, 4005.101, 4005.102, and 4054.051; 28 Tex. ADMIN. CODE § 1.502; TEX. OCC. CODE §§ 53.021–53.023; and TEX. GOV'T CODE §§ 2001.051-2001.178.

# **Factual Allegations**

#### Licensure

1. Jessica Evette Cadena (Cadena), individual identification number 18802985, holds a general lines agent license with life, accident, and health qualification issued by the Texas Department of Insurance on September 26, 2018.

# Agent Misconduct

- 2. On September 26, 2018, American National Insurance Company (ANICO) appointed Cadena as an insurance agent.
- 3. ANICO conducted an audit of Cadena's book of business and identified \$2,299.60 in premium payments that Cadena collected but failed to pay ANICO between December 2019 and August 2020.

- 4. On or about August 7, 2020, ANICO district manager J.M.R. hand delivered a letter to Cadena canceling her appointment with ANICO due to the premium deficiencies.
- 5. Cadena fraudulently converted \$2,299.60 of customer premiums to her own personal use.
- 6. ANICO covered the missing payments and continued to provide coverage to the insureds.
- 7. Cadena has failed to reimburse ANICO and still owes ANICO \$2,299.60.

## **Legal Allegations**

- 1. Cadena has committed acts for which a license holder may be denied pursuant to Tex. Ins. Code § 4005.101, as contemplated in Tex. Ins. Code § 4005.102.
- 2. Cadena has willfully violated an insurance law of this state, in violation of Tex. INS. CODE § 4005.101(b)(1).
- 3. Cadena has misappropriated, converted to her own use, or illegally withheld money belonging to an insured, insurer, or beneficiary, in violation of Tex. INS. CODE § 4005.101(b)(4).
- 4. Cadena has engaged in fraudulent or dishonest acts or practices, in violation of Tex. Ins. Code § 4005.101(b)(5).

# **Relief Sought**

If one or more of the above allegations is found to be true, the department asks the Administrative Law Judge to enter a Proposal for Decision recommending that the Commissioner of Insurance issue an order:

- 1. revoking Cadena's license;
- 2. directing Cadena to pay an administrative penalty under TEX. INS. CODE §§ 84.021-84.022;
- 3. directing Cadena to make restitution of \$2,299.60 to ANICO; and

4. imposing any other just and appropriate relief to which the department may be entitled to by law, including any combination of the above actions.


