#### General remarks and official action taken:

This is a default order taken against Adam Abdul Badi Sanders (Respondent) because he: does not hold a license in good standing in his home state of residence; failed to notify the department of administrative actions taken against him by two insurance regulators of other states; willfully violated insurance laws of this state; intentionally made a material misstatement in a license application; obtained a license by fraud or misrepresentation; engaged in fraudulent or dishonest acts or practices; and is not actively engaged in soliciting or writing insurance for the public. Respondent did not respond to a Notice of Hearing filed by the Texas Department of Insurance. This order revokes Respondent's license.

The following findings of fact and conclusions of law are adopted:

### Findings of Fact

### Failure to Respond to Notice of Hearing

1. On May 3, 2022, the department filed a Notice of Hearing, attached as Exhibit A, and on April 29, 2022, filed an Original Petition, attached as Exhibit B, with the State Office of Administrative Hearings.

- 2. The department's factual allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order as findings of fact.
- 3. The department sent the Notice of Hearing and Original Petition to Respondent's last known address provided in writing to the department, Philadelphia, Pennsylvania 19139-3111. The Notice of Hearing and Original Petition were also sent by electronic mail and to an additional address associated with Respondent, Blue Bell, Pennsylvania 19422-1952.
- 4. Respondent failed to file a written response to the Notice of Hearing within 20 days of the date the Notice of Hearing and Original Petition were mailed.

# **Conclusions of Law**

- 1. The commissioner has jurisdiction pursuant to Texas law, including TEX. INS. CODE §§ 82.051-82.055, 4001.002, 4003.007, 4005.101, 4005.102, 4054.051 and 4056.025;<sup>1</sup> and TEX. GOV'T CODE §§ 2001.051-2001.178.
- 2. The commissioner has authority to dispose of this case informally pursuant to TEX. GOV'T CODE § 2001.056; TEX. INS. CODE § 82.055; and 28 TEX. ADMIN. CODE §§ 1.47, 1.88, and 1.89.
- 3. The department provided proper notice of the hearing pursuant to TEX. GOV'T CODE §§ 2001.051, 2001.052, and 2001.054, and 28 TEX. ADMIN. CODE §§ 1.28, 1.88, 1.89, and 19.906.
- 4. Based on Respondent's failure to file a written response to the Notice of Hearing, the department is entitled to disposition by default pursuant to 28 TEX. ADMIN. CODE §§ 1.88 and 1.89.
- 5. The department's factual and legal allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order and deemed admitted as true pursuant to 28 TEX. ADMIN. CODE § 1.89.



### **ORIGINAL PETITION**

The Texas Department of Insurance seeks to take disciplinary action against Adam Abdul Badi Sanders. In support of this petition, the department makes the following allegations upon information and belief:

### Jurisdiction


The Commissioner of Insurance has jurisdiction over this matter under TEX. INS. CODE §§ 82.051-82.055, 4001.002, 4003.007, 4005.101, 4005.102, 4054.051 and 4056.025<sup>1</sup>; and TEX. GOV'T CODE §§ 2001.051-2001.178.

# **Factual Allegations**

### Licensure and Home State Revocation

 Adam Abdul Badi Sanders (Sanders), individual identification number 1416676, holds a non-resident general lines agent license with a life, accident, health, and HMO qualification issued by the department on February 21, 2020. Sanders also previously held the same kind of license from November 17, 2014, until May 13, 2017, when it expired due to his failure to renew it.

Section 19 of H.B. 4030 adds subsection (c) to Section 4056.052, which contemplates automatic suspension, cancellation, or revocation if the licensee's home state suspends, cancels, or revokes the licensee's corresponding resident license.



- 2. Sanders's current non-resident license is set to expire on May 31, 2022. However, under TEX. INS. CODE § 4003.007, Sanders may still attempt to renew his license within 90 days thereafter.
- 3. Sanders has a Texas non-resident license because he lives in Pennsylvania. This license type requires that Sanders have a resident license in good standing in his home state of Pennsylvania.
- 4. On February 8, 2021, the Insurance Department of the Commonwealth of Pennsylvania (Pennsylvania DOI) revoked Sanders's resident producer license.

### Disciplinary Action in Pennsylvania

- 5. On November 5, 2019, the Pennsylvania DOI issued a consent order in Docket No. CO19-10-011, which ordered Sanders to pay a civil penalty of \$1,000 and placed him on five years supervision. Sanders signed the consent order which stated that:
  - a. On May 27, 2017, in case number CP-51-CR-0005863-2017 in the Court of Common Pleas of Philadelphia County, Pennsylvania, Sanders was charged with Strangulation, a felony, and multiple misdemeanors, including Terroristic Threats, Simple Assault, Disorderly Conduct, and Criminal Mischief.
  - b. Sanders failed to notify the Pennsylvania DOI of these criminal charges within 30 days.
  - c. The Pennsylvania DOI issued a warning letter to Sanders on July 10, 2017, for failing to report the criminal charges.
  - d. On February 22, 2019, in the same criminal matter, Sanders pled guilty to two misdemeanors, Disorderly Conduct and Criminal Mischief. Sanders then failed to notify the Pennsylvania DOI of the final disposition.
  - e. On July 30, 2019, Sanders submitted a renewal application to the Pennsylvania DOI and improperly answered "no," to the question "Have you ever been convicted of a misdemeanor, judgment withheld or deferred..."

- f. Sanders agreed to cease and desist from certain activities described in the consent order.
- 6. On November 16, 2020, the Pennsylvania DOI suspended Sanders's resident producer license. The letter to Sanders regarding the suspension states:
  - a. The consent order, Docket No. CO19-10-011, fined Sanders \$1,000 and placed him on five years of supervision for failing to notify the Pennsylvania DOI of his criminal charges and the final disposition of those charges within 30 days. Sanders agreed to cease and desist from those activities.
  - b. On May 11, 2020, in case number MC-51-CR-0008934-2020 in the Municipal Court of Philadelphia County, Pennsylvania, Sanders was charged with Robbery, a felony, and multiple misdemeanors, including Theft by Unlawful Taking, Receiving Stolen Property, Simple Assault, and Recklessly Endangering Another Person. Sanders failed to notify the Pennsylvania DOI of these criminal charges within 30 days.
  - c. On June 8, 2020, in case number MC-51-CR-0011365-2020 in the Municipal Court of Philadelphia County, Pennsylvania, Sanders was charged with Possession of a Controlled Substance, a misdemeanor. Sanders failed to notify the Pennsylvania DOI of this charge and final disposition within 30 days.
- 7. On February 8, 2021, the Pennsylvania DOI revoked Sanders's license because Sanders failed to actively seek a hearing challenging his suspension.

### Disciplinary Action in South Carolina

8. On April 21, 2021, South Carolina Department of Insurance (South Carolina DOI) revoked Sanders's license to do business as a non-resident insurance producer within the State of South Carolina because Sanders no longer holds a license in good standing in his home state of Pennsylvania.

### Failure to Notify TDI of Administrative Actions

9. Sanders has not notified the department of the administrative actions taken by two other states' regulators. Specifically, Sanders has not notified the department of

the suspension and later revocation of his license by the Pennsylvania DOI and the revocation of his non-resident insurance producer by the South Carolina DOI.

### Material Misstatement and Obtaining a License by Misrepresentation

- 10. On February 13, 2020, Sanders submitted his application for his current license to the department.
- 11. The application asked Sanders "Have you ever been named or involved as a party in an administrative proceeding, including FINRA sanction or arbitration proceeding regarding any professional or occupational license or registration?" The application clarified that "involved" means "having a license censured, suspended, revoked, canceled, terminated; or, being assessed a fine, a cease and desist order, a prohibition order, a compliance order, placed on probation, sanctioned or surrendering a license to resolve an administrative action."
- 12. Sanders falsely answered "no," and failing to disclose the November 15, 2019, consent order issued by Pennsylvania DOI, which assessed a civil penalty and in which he agreed to cease and desist from certain activities.

### Not Actively Engaged in Soliciting or Writing Insurance

- 13. On May 13, 2017, Sanders's only active appointments with Medco Containment Life Insurance Company and Silverscript Insurance Company were canceled.
- 14. For over four years, Sanders has held no active appointment with any insurer and no intent to engage in the business of insurance. He is therefore not actively engaged in soliciting or writing insurance for the public.

### Legal Allegations

- 1. Sanders does not hold a license in good standing in his home state of residence, as required by TEX. INS. CODE § 4056.052, and is no longer qualified to hold a non-resident license in Texas.
- 2. Sanders failed to notify the department, on a monthly basis, of administrative actions taken against him by two insurance regulators of other states, in violation of TEX. INS. CODE § 4001.252(a)(3).

- 3. Sanders has also committed acts for which a license holder may be disciplined under TEX. INS. CODE §§ 4005.101 and 4005.102, because he:
  - a. has willfully violated insurance laws of this state, in violation of TEX. INS. CODE § 4005.101(b)(1);
  - b. intentionally made a material misstatement in his application for a nonresident general lines agent license, in violation of TEX. INS. CODE § 4005.101(b)(2);
  - c. obtained a license by fraud or misrepresentation, in violation of TEX. INS. CODE § 4005.101(b)(3);
  - d. has engaged in fraudulent or dishonest acts or practices, in violation of TEX. INS. CODE § 4005.101(b)(5); and
  - e. is not actively engaged in soliciting or writing insurance for the public generally, in violation of TEX. INS. CODE § 4005.101(b)(10).

# Relief Sought

If one or more of the above allegations is found to be true, the department asks the Administrative Law Judge to enter a Proposal for Decision recommending that the Commissioner of Insurance issue an order:

- 1. revoking Adam Abdul Badi Sanders's license; and
- 2. imposing any other just and appropriate relief to which the department may be entitled to by law, including any combination of the above actions.
