#### General remarks and official action taken:

This is a default order taken against Derek Jarrod Sample (Respondent) because he engaged in fraudulent or dishonest conduct. Respondent did not respond to a Notice of Hearing filed by the Texas Department of Insurance. This order revokes Respondent's license.

The following findings of fact and conclusions of law are adopted:

#### **Findings of Fact**

## Failure to Respond to Notice of Hearing

- On May 27, 2022, the department filed a Notice of Hearing, attached as Exhibit A, and an Original Petition, attached as Exhibit B, with the State Office of Administrative Hearings.
- 2. The department's factual allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order as findings of fact.
- 3. The department sent the Notice of Hearing and Original Petition to Respondent's last known address provided in writing to the department,

4. Respondent failed to file a written response to the Notice of Hearing within 20 days of the date the Notice of Hearing and Original Petition were mailed.

#### **Conclusions of Law**

- 1. The commissioner has jurisdiction under Texas law, including Tex. Ins. Code §§ 82.051-82.055, 4005.101-4005.105, and 4051.051, and Tex. Gov't Code §§ 2001.051-2001.178.
- 2. The commissioner has authority to dispose of this case informally under Tex. Gov'T CODE § 2001.056; Tex. Ins. Code § 82.055; and 28 Tex. Admin. Code §§ 1.47, 1.88, and 1.89.
- 3. The department provided proper notice of the hearing under Tex. GOV'T CODE §§ 2001.051, 2001.052, and 2001.054, and 28 Tex. ADMIN. CODE §§ 1.28, 1.88, 1.89, and 19.906.
- 4. Based on Respondent's failure to file a written response to the Notice of Hearing, the department is entitled to disposition by default under 28 Tex. ADMIN. CODE §§ 1.88 and 1.89.
- 5. The department's factual and legal allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order and deemed admitted as true under 28 Tex. ADMIN. CODE § 1.89.

#### ORIGINAL PETITION

The Texas Department of Insurance (TDI) seeks to take disciplinary action against Derek Jarrod Sample. In support of this petition, TDI makes the following allegations upon information and belief:

#### Jurisdiction

The Commissioner of Insurance has jurisdiction over this matter under Tex. INS. CODE §§ 82.051-82.055 and 4005.101, and Tex. Gov't Code §§ 2001.051-2001.178.

## **Factual Allegations**

- 1. Derek Jarrod Sample (Sample) holds a general lines agent license issued by TDI.
- 2. In May 2020, Metropolitan General Insurance Company (MetLife) terminated Sample's authority to conduct insurance business with MetLife.
- 3. Sample submitted more than one insurance policy application to MetLife for individuals who did not ask Sample to submit the application. Sample listed Sample's business address on the applications, instructing MetLife to send all correspondence to Sample's business address instead of to the individuals directly. MetLife issued the policies and Sample received commission payments. Sample subsequently contacted MetLife to cancel the insurance policies before the premium was paid, and falsely represented the reason for cancellation concerned a policyholder decision.

- 4. Sample was previously disciplined by TDI for similar conduct in Commissioner Order 2017-5038.
- 5. The following findings of fact (FOF) in Order No. 2017-5038 include conduct that demonstrates a similar pattern to the conduct alleged here:

<u>FOF #2:</u> Between April 2011 and May 2014, Sample submitted 79 applications for homeowners insurance policies to Farmers Insurance Group without valid signatures from the insureds. Sample did not collect premium payments for the policies. Sample later manually cancelled the policies prior to automatic cancellation without obtaining a signed request to cancel the policies. On several occasions, Sample reinstated policies and subsequently cancelled the policies again prior to premium payments being due.

<u>FOF #3:</u> Sample used this scheme to collect approximately \$52,000 in advanced commissions after Farmers applied charge backs to his account. Subject to Sample voluntarily entering into this consent order, Farmers has represented in writing to the department that it is not seeking restitution for the advanced commissions owed through this Enforcement case.

- 6. Among other actions, including a license suspension, the Commissioner ordered Sample to immediately notify TDI about any complaint made against Sample concerning his performance as an insurance agent and provide a written explanation detailing the steps taken to resolve it.
- 7. Sample did not notify TDI about MetLife's complaint about Sample's performance as an insurance agent. When TDI attempted to contact Sample about the complaint, Sample did not respond.

#### **Legal Allegations**

1. Sample has engaged in fraudulent or dishonest acts or practices, for which he should be disciplined per TEX. INS. CODE § 4005.101(b)(5).

- 2. Sample has misappropriated, converted to his own use, or illegally withheld money belonging to an insurer or another person, for which he should be disciplined per Tex. Ins. Code § 4005.101(b)(4).
- 3. Sample has willfully violated an insurance law of this state, for which he should be disciplined per Tex. Ins. Code §§ 4005.101(b)(1), 541.003, and 541.061.
- 4. Sample has failed to comply with an order issued under Tex. Ins. Code § 82.052, for which his license should be revoked per Tex. Ins. Code § 82.054.

### **Relief Sought**

If these allegations are proved, the Commissioner of Insurance is authorized to revoke the license held by Derek Jarrod Sample per Tex. Ins. Code §§ 82.051, 82.054, and 4005.101; additionally, the Commissioner is authorized to impose other disciplinary measures per Tex. Ins. Code §§ 82.052–82.055.
