General remarks and official action taken:

This is a default order taken against Kashwon Zaimier Davis (Respondent) because he was indicted for the felony offense of Fraud Use or Possession of Identifying Information, engaged in fraudulent and dishonest conduct, and failed to respond to department requests. Respondent did not respond to a Notice of Hearing filed by the Texas Department of Insurance. This order revokes Respondent's license.

The following findings of fact and conclusions of law are adopted:

Findings of Fact

Failure to Respond to Notice of Hearing

- 1. On July 7, 2022, the department filed a Notice of Hearing, attached as Exhibit A, and an Original Petition, attached as Exhibit B, with the State Office of Administrative Hearings.
- 2. The department's factual allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order as findings of fact.

- 3. The department sent the Notice of Hearing and Original Petition to Respondent's last known address provided in writing to the department, Dallas, Texas 75243. The Notice of Hearing and Original Petition were also sent by electronic mail.
- 4. Respondent failed to file a written response to the Notice of Hearing within 20 days of the date the Notice of Hearing and Original Petition were mailed.

Conclusions of Law

- 1. The commissioner has jurisdiction under Texas law, including Tex. Ins. Code §§ 82.051-82.055, 4001.002, 4001.102, 4001.105, 4005.101-4005.105, and 4101.051; Tex. Occ. Code §§ 53.021-53.023; 28 Tex. Admin. Code § 1.502; and Tex. Gov't Code §§ 2001.051-2001.178.
- 2. The commissioner has authority to dispose of this case informally under Tex. Gov'T CODE § 2001.056; Tex. Ins. Code § 82.055; and 28 Tex. Admin. Code §§ 1.47, 1.88, and 1.89.
- 3. The department provided proper notice of the hearing under Tex. GOV'T CODE §§ 2001.051, 2001.052, and 2001.054, and 28 Tex. ADMIN. CODE §§ 1.28, 1.88, 1.89, and 19.906.
- 4. Based on Respondent's failure to file a written response to the Notice of Hearing, the department is entitled to disposition by default under 28 Tex. ADMIN. CODE §§ 1.88 and 1.89.
- 5. The department's factual and legal allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order and deemed admitted as true under 28 Tex. ADMIN. CODE § 1.89.

Factual Allegations

Licensure and Background

 Kashwon Zaimier Davis (Davis), individual identification number 2092378, holds a life agent license originally issued by the Texas Department of Insurance on August 24, 2019.

<u>Criminal History</u>

2. On or about March 1, 2022, Davis was indicted for Fraud Use or Possession of Identifying Information, a felony, in case number F2139565 in the Dallas County, Texas.

Failure to Respond

- 3. On May 12, 2022, the department made a written request for information to Davis. However, Davis failed to respond to the request.
- 4. On May 23, 2022, the department made a written request for information to Davis. However, Davis failed to respond to this request as well.

Legal Allegations

- 1. Davis willfully violated an insurance law of this state, in violation of Tex. INS. CODE § 4005.101(b)(1).
- 2. Davis engaged in fraudulent or dishonest acts or practices, in violation of Tex. INS. CODE § 4005.101(b)(5).
- 3. Davis violated Tex. Ins. Code § 38.001 by failing to respond to a department inquiry in writing not later than the 15th day after the date the inquiry was received.

Relief Sought

If one or more of the above allegations is found to be true, the department asks the Administrative Law Judge to enter a Proposal for Decision recommending that the Commissioner of Insurance issue an order:

- 1. revoking Kashwon Zaimier Davis's license; and
- 2. imposing any other just and appropriate relief to which the department may be entitled to by law, including any combination of the above actions.
