#### General remarks and official action taken:

This is a default order taken against Colton Julius Kuper (Respondent) because he collected premiums from insureds and failed to submit them to the insurer and because he failed to respond to a department inquiry. Respondent did not respond to a Notice of Hearing filed by the Texas Department of Insurance. This order revokes Respondent's license.

The following findings of fact and conclusions of law are adopted:

## **Findings of Fact**

# Failure to Respond to Notice of Hearing

- 1. On September 29, 2022, the department filed a Notice of Hearing, attached as Exhibit A, and an Original Petition, attached as Exhibit B, with the State Office of Administrative Hearings.
- 2. The department's factual allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order as findings of fact.

- 3. The department sent the Notice of Hearing and Original Petition to Respondent's last known address provided in writing to the department, Dalhart, Texas 79022. The Notice of Hearing and Original Petition were also sent by electronic mail to Respondent.
- 4. Respondent failed to file a written response to the Notice of Hearing within 20 days of the date the Notice of Hearing and Original Petition were mailed.

#### **Conclusions of Law**

- 1. The commissioner has jurisdiction under Texas law, including Tex. Ins. Code §§ 82.051-82.055, 4001.002, 4001.102, 4001.105, 4005.101-4005.105, 4051.051, 4054.051 and 4101.051; Tex. Occ. Code §§ 53.021-53.023; 28 Tex. Admin. Code § 1.502; and Tex. Gov't Code §§ 2001.051-2001.178.
- 2. The commissioner has authority to dispose of this case informally under Tex. Gov'T CODE § 2001.056; Tex. Ins. CODE § 82.055; and 28 Tex. ADMIN. CODE §§ 1.47, 1.88, and 1.89.
- 3. The department provided proper notice of the hearing under Tex. GOV'T CODE §§ 2001.051, 2001.052, and 2001.054, and 28 Tex. ADMIN. CODE §§ 1.28, 1.88, 1.89, and 19.906.
- 4. Based on Respondent's failure to file a written response to the Notice of Hearing, the department is entitled to disposition by default under 28 Tex. ADMIN. CODE §§ 1.88 and 1.89.
- 5. The department's factual and legal allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order and deemed admitted as true under 28 Tex. ADMIN. CODE § 1.89.

The Texas Department of Insurance seeks to take disciplinary action against Colton Julius Kuper. In support of this petition, the department makes the following allegations upon information and belief:

#### Jurisdiction

The Commissioner of Insurance has jurisdiction over this matter under Tex. INS. CODE §§ 82.051-82.055, 4001.002, 4005.101, 4005.102, 4051.051 and 4054.051, and Tex. Gov'T CODE §§ 2001.051-2001.178.

### **Factual Allegations**

- 1. Colton Julius Kuper (Kuper), individual identification number 2229779, holds a general lines license with property and casualty and life, accident, health, and HMO qualifications issued by the department on September 4, 2020.
- 2. Kuper was an agent appointed with Farmers Insurance companies from August 27, 2020, until May 12, 2022.
- 3. Between August 2021 and February 2022, Kuper collected \$6,727 in premiums in check or cash from insureds and failed to deposit them with Farmers Insurance.
- 4. Kuper endorsed and deposited a premium payment check from Education Credit Union in the amount of \$4,253.23 into an unknown bank account.

5. The department sent Kuper a request for information pursuant to Tex. Ins. Code § 38.001 on June 24, 2022, and he failed to respond within 15 days of receiving the request.

# **Legal Allegations**

- 1. Kuper misappropriated, converted to his own use or illegally withheld money belonging to an insurer, HMO, insured, enrollee or beneficiary as contemplated by Tex. Ins. Code § 4005.101(b)(4).
- 2. Kuper engaged in fraudulent or dishonest acts or practices, as contemplated by Tex. Ins. Code § 4005.101(b)(5).
- 3. Kuper violated Tex. Ins. Code § 38.001 by failing to respond to a department inquiry in writing not later than the 15<sup>th</sup> day after the date the inquiry was received.

## **Relief Sought**

If one or more of the above allegations is found to be true, the department asks the Administrative Law Judge to enter a Proposal for Decision recommending that the Commissioner of Insurance issue an order:

- 1. revoking Kuper's license, and
- 2. imposing any other just and appropriate relief to which the department may be entitled to by law, including any combination of the above actions.
