General remarks and official action taken:

This is a default order taken against Leslie Juanita Hernandez and Expert Insurance Agency (collectively referred to as Respondents) because Respondents engaged in acts constituting the business of insurance without a license. Respondents did not respond to a Notice of Hearing filed by the Texas Department of Insurance. This order directs Respondents to cease and desist from engaging in the business of insurance without a license.

The following findings of fact and conclusions of law are adopted:

Findings of Fact

Failure to Respond to Notice of Hearing

1. On November 10, 2022, the department filed a Notice of Hearing, attached as Exhibit A, and an Original Petition, attached as Exhibit B, with the State Office of Administrative Hearings.

- 2. The department's factual allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order as findings of fact.
- 3. The department sent the Notice of Hearing and Original Petition to Respondents' last known address provided in writing to the department, Nacogdoches, Texas 75964-6155. The Notice of Hearing and Original Petition were also sent via eFile.
- 4. Respondents failed to file a written response to the Notice of Hearing within 20 days of the date the Notice of Hearing and Original Petition were mailed.

Conclusions of Law

- 1. The commissioner has jurisdiction under Texas law, including Tex. Ins. Code §§ 82.051-82.055, 84.021-84.044, 101.101-101.151, 4005.102, 4051.101; 28 Tex. ADMIN. CODE § 19.902; and Tex. GOV'T CODE §§ 2001.051-2001.178.
- 2. The commissioner has authority to dispose of this case informally under Tex. Gov'T CODE § 2001.056; Tex. Ins. CODE § 82.055; and 28 Tex. ADMIN. CODE §§ 1.47, 1.88, and 1.89.
- 3. The department provided proper notice of the hearing under Tex. GOV'T CODE §§ 2001.051, 2001.052, and 2001.054, and 28 Tex. ADMIN. CODE §§ 1.28, 1.88, 1.89, and 19.906.
- 4. Based on Respondents' failure to file a written response to the Notice of Hearing, the department is entitled to disposition by default under 28 Tex. ADMIN. CODE §§ 1.88 and 1.89.
- 5. The department's factual and legal allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order and deemed admitted as true under 28 Tex. ADMIN. CODE § 1.89.

Order

It is ordered that Leslie Juanita Hernandez and Expert Insurance Agency cease and desist from engaging in the business of insurance without a license. A copy of this order will

ORIGINAL PETITION

The Texas Department of Insurance seeks to take disciplinary action against Leslie Juanita Hernandez and Expert Insurance Agency. In support of this petition, the department makes the following allegations upon information and belief:

Jurisdiction

The Commissioner of Insurance has jurisdiction over this matter under Tex. Ins. Code §§ 82.051-82.056, 84.021-84.044, 101.101-101.151, 4005.102, and 4051.101; Tex. Gov'T Code §§ 2001.051-2001.178; and 28 Tex. ADMIN. Code §§ 19.902.

Factual Allegations

Licensure

- 1. Leslie Juanita Hernandez (Hernandez), individual identification number 1108330, previously held a limited lines agent license originally issued by the Texas Department of Insurance on May 16, 2012. Official Order No. 2018-5591 was issued on July 30, 2018, which revoked Hernandez's limited lines agent license.
- 2. Hernandez has used the name Expert Insurance Agency (Expert Insurance) while engaging in the business of insurance since at least 2020. Expert Insurance is not licensed or registered with the department.

Misconduct and the Unauthorized Business of Insurance

- 3. Progressive Casualty Insurance Company (Progressive) investigated a possible unauthorized agent writing business via the online portal intended for consumer use. The investigation revealed 128 new policies were written through the Progressive.com website by Hernandez and Expert Insurance between July 30, 2019, and October 23, 2020.
- 4. During the investigation, Progressive spoke with several of the policyholders who confirmed they made payments to Expert Insurance in Nacogdoches, Texas. Progressive's investigation confirmed the insurance activity was linked to Hernandez and Expert Insurance, an unlicensed and unauthorized broker.
- 5. Some of the policyholders Progressive spoke with confirmed they made cash payments to Hernandez and Expert Insurance, but Hernandez failed to remit the payments to the insurer often resulting in cancellation of the policies due to non-payment.

Legal Allegations

1. Hernandez has engaged in acts constituting the business of insurance without a license as defined in Tex. Ins. Code §§ 101.102, 4001.101, and 4051.101 and 28 Tex. ADMIN. Code § 19.902.

Relief Sought

If one or more of the above allegations is found to be true, the department asks the Administrative Law Judge to enter a Proposal for Decision recommending that the Commissioner of Insurance issue an order:

- 1. ordering Leslie Juanita Hernandez and Expert Insurance Agency to cease and desist from engaging in the business of insurance without a license;
- 2. directing Leslie Juanita Hernandez to pay an administrative penalty under Tex. INS. Code § 101.103.
- 3. directing Leslie Juanita Hernandez to make restitution to the victims under Tex. INS. CODE § 101.103; and
- 4. imposing any other just and appropriate relief to which the department may be entitled to by law, including any combination of the above actions.
