#### General remarks and official action taken:

This is a default order taken against Terry Joe Stanley (Respondent) for the submission of fictitious information on insurance claims filed by his rental car business. Respondent did not respond to a Notice of Hearing filed by the Texas Department of Insurance. This order revokes Respondent's license.

The following findings of fact and conclusions of law are adopted:

#### **Findings of Fact**

#### Failure to Respond to Notice of Hearing

- On February 16, 2023, the department filed a Notice of Hearing, attached as Exhibit A, and an Original Petition, attached as Exhibit B, with the State Office of Administrative Hearings.
- 2. The department's factual allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order as findings of fact.

- 3. The department sent the Notice of Hearing and Original Petition to Respondent's last known address provided in writing to the department, Huntington, TX 75949-3639.
- 4. Respondent failed to file a written response to the Notice of Hearing within 20 days of the date the Notice of Hearing and Original Petition were mailed.

### **Conclusions of Law**

- 1. The commissioner has jurisdiction under Texas law, including TEX. INS. CODE §§ 82.051-82.055, 4001.002, 4001.102, 4001.105, 4005.101-4005.105, and 4101.051, and TEX. GOV'T CODE §§ 2001.051-2001.178.
- 2. The commissioner has authority to dispose of this case informally under TEX. GOV'T CODE § 2001.056; TEX. INS. CODE § 82.055; and 28 TEX. ADMIN. CODE §§ 1.47, 1.88, and 1.89.
- 3. The department provided proper notice of the hearing under TEX. GOV'T CODE §§ 2001.051, 2001.052, and 2001.054, and 28 TEX. ADMIN. CODE §§ 1.28, 1.88, 1.89, and 19.906.
- 4. Based on Respondent's failure to file a written response to the Notice of Hearing, the department is entitled to disposition by default under 28 TEX. ADMIN. CODE §§ 1.88 and 1.89.
- 5. The department's factual and legal allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order and deemed admitted as true under 28 TEX. ADMIN. CODE § 1.89.

#### ORIGINAL PETITION

The Texas Department of Insurance seeks to take disciplinary action against Terry Joe Stanley. In support of this petition, the department makes the following allegations upon information and belief:

#### Jurisdiction

The Commissioner of Insurance has jurisdiction over this matter under TEX. INS. CODE §§ 82.051-82.055, 84.021-84.044, 4001.002, 4005.102, 4101.051, 4101.053, and TEX. GOV'T CODE §§ 2001.051-2001.178.

### **Factual Allegations**

- 1. Terry Joe Stanley (Stanley), individual identification number 499640, holds an adjuster license originally issued by the Texas Department of Insurance (TDI) on March 19, 2003.
- According to Secretary of State documents: Stanley became the managing member of Rental by Concierge, LLC (Concierge) on August 5, 2011. Stanley signed Concierge's 2012 franchise tax report and Concierge's charter was forfeited on February 21, 2014.
- 3. In September 2017, following Hurricane Harvey, 10 claims were made to National Interstate Insurance Company (NIIC) for flood/water damage to vehicles rented through Concierge.

B

- 4. NIIC conducted an investigation into the claims, and determined that Stanley was the owner of Concierge and that all 10 claims submitted contained fraudulent or fictitious information. Stanley refused to cooperate with NIIC's investigation.
- 5. On September 1, 2017, documents were submitted to NIIC on claim number ending in 2832 purporting that RS took out an insurance policy when she rented a vehicle from Concierge on August 25. RS gave a statement under oath to NIIC indicating the following:
  - a. She had no discussions with Concierge regarding insurance and did not authorize anyone to file a claim for the rental or to sign her name;
  - b. The signature on the Direction to Pay, submitted to NIIC, was not hers.
  - 6. On September 1, 2017, documents were submitted to NIIC on claim number ending in 2966 purporting that AS took out an insurance policy when she rented a vehicle from Concierge. AS gave a statement under oath to NIIC indicating the following:
    - a. The rental agreement she signed with Concierge was different from the one that had been submitted to NIIC for the claim;
    - b. The signatures on the Claims Check off List and Renters Collision Loss Report, submitted to NIIC, were not hers;
    - c. She did not give consent for the filing of the insurance claim and did not authorize anyone to sign her name on the documents;
    - d. She did not take out any insurance to cover the vehicle.
  - 7. On September 19, 2017, documents were submitted to NIIC on claim number ending in 5273 purporting that PS took out an insurance policy when she rented a vehicle from Concierge. PS gave a statement under oath to NIIC indicating the following:
    - a. She did not purchase any insurance on the rental vehicle;
    - b. She did not sign the claim documents submitted to NIIC, and she did not authorize anyone to submit the claim documents on her behalf.
  - 8. The remaining seven claims filed by Concierge in September 2017 are substantially similar in nature to the three claims described above.

- 9. Six of the 10 claims, totaling \$63,363.62, were paid before NIIC discovered the information submitted was untrue. NIIC sent a demand letter to Stanley for the unduly paid claims, but received no response.
- 10. On December 8, 2022, TDI sent an official inquiry letter to Stanley at his address of record, indicating a response was required within fifteen days of receipt. On January 10, 2023, USPS records procured a signature appearing to be Stanley's, upon delivery to Stanley's address of record. This inquiry was also sent to Stanley's email of record on December 8, 2022. Stanley failed to respond to TDI's inquiry.

### Legal Allegations

- 1. Stanley committed acts for which a license holder may be disciplined under TEX. INS. CODE § 4005.101, as contemplated by TEX. INS. CODE § 4005.102.
- 2. Stanley engaged in fraudulent or dishonest acts or practices, in violation of TEX. INS. CODE § 4005.101(b)(5).
- 3. Stanley failed to respond to TDI's written inquiry within the statutory time limit, in violation of TEX. INS. CODE § 38.001.

### **Relief Sought**

If one or more of the above allegations is found to be true, the department asks the Administrative Law Judge to enter a Proposal for Decision recommending that the Commissioner of Insurance issue an order:

- 1. revoking Terry Joe Stanley's license; and
- 2. imposing any other just and appropriate relief to which the department may be entitled to by law, including any combination of the above actions.
