General remarks and official action taken:

The subject of this default order is whether an adjuster all lines license should be issued to Kyle Terez Crockett (Respondent). Respondent did not respond to a Notice of Hearing filed by the Texas Department of Insurance. This order denies Respondent's license application.

The following findings of fact and conclusions of law are adopted:

Findings of Fact

Failure to Respond to Notice of Hearing

- On March 31, 2023, the department filed a Notice of Hearing, attached as Exhibit
 A, and an Original Petition, attached as Exhibit B, with the State Office of
 Administrative Hearings.
- 2. The department's factual allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order as findings of fact.
- 3. The department sent the Notice of Hearing and Original Petition to Respondent's last known address provided in writing to the department,

Houston, Texas 77021. The Notice of Hearing and Original Petition were also sent by electronic mail to the Respondent.

4. Respondent failed to file a written response to the Notice of Hearing within 20 days of the date the Notice of Hearing and Original Petition were mailed.

Conclusions of Law

- 1. The commissioner has jurisdiction under Texas law, including Tex. Ins. Code §§ 82.051-82.055, 4001.002, 4001.102, 4005.101-4005.102, and 4101.051; Tex. Occ. Code §§ 53.021-53.023; 28 Tex. Admin. Code § 1.502; and Tex. Gov't Code §§ 2001.051-2001.178.
- 2. The commissioner has authority to dispose of this case informally under Tex. Gov'T CODE § 2001.056; Tex. Ins. Code § 82.055; and 28 Tex. Admin. Code §§ 1.47, 1.88, and 1.89.
- 3. The department provided proper notice of the hearing under Tex. GOV'T CODE §§ 2001.051, 2001.052, and 2001.054, and 28 Tex. ADMIN. CODE §§ 1.28, 1.88, 1.89, and 19.906.
- 4. Based on Respondent's failure to file a written response to the Notice of Hearing, the department is entitled to disposition by default under 28 Tex. ADMIN. CODE §§ 1.88 and 1.89.
- 5. The department's factual and legal allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order and deemed admitted as true under 28 Tex. ADMIN. CODE § 1.89.

ORIGINAL PETITION

The Texas Department of Insurance seeks to deny Kyle Terez Crockett's license application. In support of this petition, the department makes the following allegations upon information and belief:

Jurisdiction

The Commissioner of Insurance has jurisdiction over this matter under Tex. Ins. Code §§ 82.051-82.055, 4001.002, 4005.101, 4005.102, and 4101.051, 28 Tex. Admin. Code §§ 1.502, Tex. Occ. Code §§ 53.021–53.023, and Tex. Gov't Code §§ 2001.051–2001.178.

Factual Allegations

License Application

- 1. On June 30, 2021, Kyle Terez Crockett (Crockett) applied for an adjuster all lines license to be issued by the department.
- 2. On July 30, 2021, the department proposed to deny Crockett's application based on his criminal history. Crockett appealed that decision and made a written request for a hearing.

Felony Tampering with Government Records

3. On November 13, 2020, Crockett pled guilty to the second degree felony of tampering with a government record in Cause No. 167018701010 in the

Harris County, Texas. Crockett admitted to TDI that he had tried to fraudulently purchase a vehicle with a fake driver's license and fake social security number.

4. Crockett was placed on deferred adjudication community supervision for three years, with his community supervision set to expire on November 12, 2023.

Legal Allegations

- 1. Crockett has committed an act for which a license may be denied pursuant to TEX. INS. CODE § 4005.101(b) because he engaged in fraudulent or dishonest acts or practices, as contemplated by TEX. INS. CODE § 4005.101(b)(5).
- 2. Pursuant to Tex. Occ. Code § 53.021(a) and (d), the commissioner may deny Crockett's application and consider him to have been convicted of felony tampering of a government record due to the following:
 - a. Crockett's has not completed the period of community supervision, pursuant to Tex. Occ. Code § 53.021(d)(1)(B)(i); and
 - b. Pursuant to Tex. Occ. Code § 53.021(d)(2), the department determined that:
 - i. Crockett continues to pose a threat to public safety; or
 - ii. employment of Crockett in the licensed occupation would create a situation in which he has the opportunity to repeat the prohibited conduct.
- 3. Crockett committed a felony offense and engaged in fraudulent or dishonest activity that directly relate to the duties and responsibilities of the licensed occupation, as contemplated in 28 Tex. ADMIN. CODE § 1.502(d) and (f).
- 4. Crockett committed an offense TDI considers to be of such serious nature that it is of prime importance in determining fitness for licensure or authorization, as contemplated by 28 Tex. Admin. Code § 1.502(e).
- 5. Crockett committed an offense for which fraud, dishonesty, or deceit is an essential element, as contemplated by 28 Tex. ADMIN. CODE § 1.502(e)(1).

- 6. Crockett committed a felony involving moral turpitude, as contemplated in 28 Tex. ADMIN. CODE § 1.502(e)(3).
- 7. Department guidelines, 28 Tex. ADMIN. CODE § 1.502(c)-(e), emphasize that the department:
 - a. considers it very important that applicants be honest, trustworthy, and reliable;
 - b. may refuse to issue an original license and revoke a license if the department determines that the applicant has committed a felony or misdemeanor, or has engaged in fraudulent or dishonest activity that directly relates to the duties and responsibilities of the licensed occupation;
 - c. considers any offense for which fraud, dishonesty, or deceit is an essential element to be of such a serious nature that it is of prime importance when determining fitness for licensure, pursuant to 28 Tex. ADMIN. CODE 1.502(e)(1); and
 - d. considers any felony involving moral turpitude to be of such a serious nature that it is of prime importance when determining fitness for licensure, pursuant to 28 Tex. Admin. Code § 1.502(e)(3).

Relief Sought

If one or more of the above allegations is found to be true, the department asks the Administrative Law Judge to enter a Proposal for Decision recommending that the Commissioner of Insurance issue an order:

- 1. denying Kyle Terez Crockett's license application; and
- 2. imposing any other just and appropriate relief to which the department may be entitled to by law, including any combination of the above actions.
