General remarks and official action taken:

The subject of this default order is whether a General Lines life, accident and health license should be issued to Enrique Gutierrez (Respondent). Respondent did not respond to a Notice of Hearing filed by the Texas Department of Insurance. This order denies Respondent's license application.

The following findings of fact and conclusions of law are adopted:

Findings of Fact

Failure to Respond to Notice of Hearing

- On June 12, 2023, the department filed a Notice of Hearing, attached as Exhibit A, and an Original Petition, attached as Exhibit B, with the State Office of Administrative Hearings.
- 2. The department's factual allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order as findings of fact.
- The department sent the Notice of Hearing and Original Petition to Respondent's last known address provided in writing to the department,

Mission, TX 78572. The Notice of Hearing and Original Petition were also sent to an additional address associated with Respondent: Mission, TX 78572.

4. Respondent failed to file a written response to the Notice of Hearing within 20 days of the date the Notice of Hearing and Original Petition were mailed.

Conclusions of Law

- 1. The commissioner has jurisdiction under Texas law, including Tex. Ins. Code §§ 82.051-82.055, 4001.002, 4001.102, 4001.105, 4005.101-4005.105, 4101.051, and 4054.051; Tex. Occ. Code §§ 53.021-53.023; 28 Tex. Admin. Code § 1.502; and Tex. Gov't Code §§ 2001.051-2001.178.
- 2. The commissioner has authority to dispose of this case informally under Tex. Gov'T CODE § 2001.056; Tex. Ins. Code § 82.055; and 28 Tex. Admin. Code §§ 1.47, 1.88, and 1.89.
- 3. The department provided proper notice of the hearing under Tex. GOV'T CODE §§ 2001.051, 2001.052, and 2001.054; and 28 Tex. ADMIN. CODE §§ 1.28, 1.88, 1.89, and 19.906.
- 4. Based on Respondent's failure to file a written response to the Notice of Hearing, the department is entitled to disposition by default under 28 Tex. ADMIN. CODE §§ 1.88 and 1.89.
- 5. The department's factual and legal allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order and deemed admitted as true under 28 Tex. ADMIN. CODE § 1.89.

ORIGINAL PETITION

The Texas Department of Insurance (TDI) seeks to deny Enrique Gutierrez's general lines life, accident and health license application. In support of this petition, the department makes the following allegations upon information and belief:

Jurisdiction

The Commissioner of Insurance has jurisdiction over this matter under Tex. Ins. Code §§ 82.051-82.055, 4001.002, 4005.101, 4005.102, 4054.051; 28 Tex. Admin. Code § 1.502; Tex. Occ. Code §§ 53.021-53.023; and Tex. Gov't Code §§ 2001.051-2001.178.

Factual Allegations

- 1. On April 22, 2022, Gutierrez applied for a general lines life, accident and health agent license.
- 2. On January 24, 2023, a proposed summary denial letter was sent to Gutierrez denying his application based on his criminal history. Gutierrez disclosed his criminal history on his application.
- 3. On February 24, 2023, TDI acknowledged receipt of Gutierrez's request for a hearing on the denial.

- 4. On September 23, 2013, Gutierrez entered a guilty plea to Aggravated Sexual Assault of a Child, a first-degree felony offense, in the 206th District Court of Hidalgo County, case number CR-2351-13-D. The court placed Gutierrez on an eight-year community supervision probationary period with deferred adjudication.
- 5. On May 5, 2020, while still on probation for the above-mentioned offense, Gutierrez was convicted of Driving While Intoxicated, a Class A misdemeanor, in the Hidalgo County Court at Law No. 8, case number CR-20-03171-H. Gutierrez was sentenced to 365 days confinement in the Hidalgo County Jail and ordered to pay a \$250 fine. However the court suspended the imposition of his sentence and placed Gutierrez on community supervision for two years.
- 6. On September 22, 2021, Gutierrez completed his eight-year community supervision probationary period relating to his Aggravated Sexual Assault of a Child offense.
- 7. On May 16, 2022, Gutierrez was discharged from the probation period resulting from his Driving While Intoxicated offense.
- 8. Gutierrez is currently registered on the Texas Public Sex Offender Registry.

Legal Allegations

- 1. As contemplated by Tex. Occ. Code § 53.021(d)(1)(A), TDI may consider Gutierrez to have been convicted of Aggravated Sexual Assault of a Child, a first-degree felony, because he was charged with:
 - a. an offense described by Article 62.001(5), Code of Criminal Procedure; and
 - b. after consideration of the factors described by Tex. Occ. Code 53.022 and 53.0223(a), the TDI determined that 1) Gutierrez may pose a continued threat to public safety or 2) licensing Gutierrez would create a situation in which he has an opportunity to repeat the prohibited conduct.
- 2. Gutierrez committed acts for which a license may be denied under Tex. Occ. Code, Chapter 53, Subchapter B, because he was convicted of:

- a. an offense listed in Article 42A.054, Code of Criminal Procedure, as contemplated by Tex. Occ. Code § 53.021(a)(2); and
- b. a sexually violent offense, as defined by Article 62.001, Code of Criminal Procedure, as contemplated by Tex. Occ. Code § 53.021(a)(3).
- 3. TDI may deny Gutierrez's license application because he has committed an offense of such serious nature that it is of prime importance in determining fitness of licensure, as contemplated by 28 Tex. ADMIN. CODE § 1.502(e)(4)(B).
- 4. The factors listed in 28 Tex. ADMIN. CODE § 1.502(h) do not outweigh the serious nature of Gutierrez's criminal history, as 28 Tex. ADMIN. CODE § 1.502(f) contemplates.

Relief Sought

If one or more of the above allegations is found to be true, the department asks the Administrative Law Judge to enter a Proposal for Decision recommending that the Commissioner of Insurance issue an order:

- 1. denying Gutierrez's license application, and
- 2. granting any other just and appropriate relief to which TDI may be entitled to by law.
