General remarks and official action taken:

This is a default order taken against Blanca Estela Rodriguez (Respondent) because she improperly listed customers as homeowners and provided proof of homeownership that did not belong to the named insureds, providing them a more favorable premium than what they were entitled to receive. Respondent did not respond to a Notice of Hearing filed by the Texas Department of Insurance (TDI). This order revokes Respondent's license.

The following findings of fact and conclusions of law are adopted:

Findings of Fact

Failure to Respond to Notice of Hearing

- On August 2, 2023, TDI filed a Notice of Hearing, attached as Exhibit A, and an Original Petition, attached as Exhibit B, with the State Office of Administrative Hearings.
- 2. TDI's factual allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order as findings of fact.

- 3. TDI sent the Notice of Hearing and Original Petition to Respondent's last known address provided in writing to the department, Eagle Pass, Texas 78852. The Notice of Hearing and Original Petition were also sent by electronic mail.
- 4. Respondent failed to file a written response to the Notice of Hearing within 20 days of the date the Notice of Hearing and Original Petition were mailed.

Conclusions of Law

- 1. The commissioner has jurisdiction under Texas law, including Tex. Ins. Code §§ 82.051-82.055, 4001.002, 4001.102, 4001.105, 4005.101-4005.105, and 4101.051; Tex. Occ. Code §§ 53.021-53.023; 28 Tex. Admin. Code § 1.502; and Tex. Gov't Code §§ 2001.051-2001.178.
- 2. The commissioner has authority to dispose of this case informally under Tex. Gov'T CODE § 2001.056; Tex. Ins. CODE § 82.055; and 28 Tex. ADMIN. CODE §§ 1.47, 1.88, and 1.89.
- 3. TDI provided proper notice of the hearing under Tex. Gov't Code §§ 2001.051, 2001.052, and 2001.054; and 28 Tex. ADMIN. Code §§ 1.28, 1.88, 1.89, and 19.906.
- 4. Based on Respondent's failure to file a written response to the Notice of Hearing, TDI is entitled to disposition by default under 28 Tex. ADMIN. CODE §§ 1.88 and 1.89.
- 5. TDI's factual and legal allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order and deemed admitted as true under 28 Tex. ADMIN. CODE § 1.89.



ORIGINAL PETITION

The Texas Department of Insurance seeks to take disciplinary action against Blanca Estela Rodriguez. In support of this petition, the department makes the following allegations upon information and belief:

Jurisdiction

The Commissioner of Insurance has jurisdiction over this matter under Tex. INS. CODE §§ 82.051-82.055, 4001.002, 4005.101, 4005.102, and 4051.051; and Tex. Gov't Code §§ 2001.051-2001.178.

Factual Allegations

Licensure

1. Blanca Estela Rodriguez (Rodriguez), individual identification number 2289507, was issued a general lines agent license with a property and casualty qualification by the department on December 29, 2020.

Allstate Cancelation

2. On January 24, 2023, the department received correspondence from Allstate Insurance Company (Allstate) with notice that Rodriguez's appointment with them had been canceled.

3. Allstate canceled Rodriguez for improperly listing customers as homeowners and providing proof of homeownership that did not belong to the named insureds, in order to provide them a more favorable premium than they were entitled to receive.

Failure to Respond to the Department's Inquiry

4. On April 11, 2023, the department mailed a request for information to Rodriguez about the above matter, informing her that she must respond no later than 15 days after receipt of the inquiry. Rodriguez did not respond to the department's inquiry.

Legal Allegations

- 1. Rodriguez has committed acts for which a license holder may be disciplined under Tex. Ins. Code §§ 4005.101 and 4005.102, because she:
 - a. has willfully violated insurance laws of this state, in violation of Tex. Ins. Code § 4005.101(b)(1),
 - b. has engaged in fraudulent or dishonest acts or practices, in violation of Tex. INS. CODE § 4005.101(b)(5), and
 - c. failed to respond to the department's written inquiry not later than the 15th day after the date of each inquiry, in violation of Tex. INS. CODE § 38.001.

Relief Sought

If one or more of the above allegations is found to be true, the department asks the Administrative Law Judge to enter a Proposal for Decision recommending that the Commissioner of Insurance issue an order:

- 1. revoking Blanca Estela Rodriguez's license; and
- 2. imposing any other just and appropriate relief to which the department may be entitled to by law, including any combination of the above actions.
