General remarks and official action taken:

The subject of this default order is whether a general life, accident and health license should be issued to Tony S. Randle (Respondent). Respondent did not respond to a Notice of Hearing filed by the Texas Department of Insurance (TDI). This order denies Respondent's license application.

The following findings of fact and conclusions of law are adopted:

Findings of Fact

Failure to Respond to Notice of Hearing

- On July 31, 2023, TDI filed a Notice of Hearing, attached as Exhibit A, and an Original Petition, attached as Exhibit B, with the State Office of Administrative Hearings.
- 2. TDI's factual allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order as findings of fact.
- 3. TDI sent the Notice of Hearing and Original Petition to Respondent's last known address provided in writing to the department, Waco,

Texas 76710. The Notice of Hearing and Original Petition were also sent by electronic mail.

4. Respondent failed to file a written response to the Notice of Hearing within 20 days of the date the Notice of Hearing and Original Petition were mailed.

Conclusions of Law

- 1. The commissioner has jurisdiction under Texas law, including Tex. Ins. Code §§ 82.051-82.055, 4001.002, 4001.102, 4001.105, 4005.101-4005.105, and 4051.051; Tex. Occ. Code §§ 53.021-53.023; 28 Tex. Admin. Code § 1.502; and Tex. Gov't Code §§ 2001.051-2001.178.
- 2. The commissioner has authority to dispose of this case informally under Tex. Gov'T CODE § 2001.056; Tex. Ins. Code § 82.055; and 28 Tex. Admin. Code §§ 1.47, 1.88, and 1.89.
- 3. TDI provided proper notice of the hearing under Tex. GOV'T CODE §§ 2001.051, 2001.052, and 2001.054, and 28 Tex. ADMIN. CODE §§ 1.28, 1.88, 1.89, and 19.906.
- 4. Based on Respondent's failure to file a written response to the Notice of Hearing, TDI is entitled to disposition by default under 28 Tex. ADMIN. CODE §§ 1.88 and 1.89.
- 5. TDI's factual and legal allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order and deemed admitted as true under 28 Tex. Admin. Code § 1.89.

ORIGINAL PETITION

The Texas Department of Insurance (TDI) seeks to deny Tony S. Randle's general life accident and health license application. In support of this petition, TDI makes the following allegations upon information and belief:

Jurisdiction

The Commissioner of Insurance has jurisdiction over this matter under Tex. Ins. Code §§ 82.051-82.055, 4001.002, 4005.101, 4005.102, and 4054.051; Tex. Gov't Code §§ 2001.051-2001.178; Tex. Occ. Code §§ 53.021–53.023; and 28 Tex. Admin. Code § 1.502.

Factual Allegations

License Application:

- 1. Tony S. Randle (Randle) applied for a general life, accident, and health license on or about November 25, 2022, and disclosed a criminal history.
- On or about November 29, 2022, TDI requested that Randle provide certified copies of court documents for all of his offenses. Randle complied with TDI's request.
- 3. On or about April 19, 2023, TDI proposed to deny his license application based on his criminal history.

Criminal History:

Case no. 20143126CR2--Assault Family Violence

- 4. On or about November 5, 2014, in case no. 20143126CR2, in the County Court at Law, McLennan County, Texas, Randle pleaded guilty to Class A misdemeanor Assault Family Violence. The court sentenced him to 15 months deferred adjudication. It ordered him to complete 15 hours of community service, a batterers intervention and protection program (BIPP), and a DWI/Drug Court Program. The court also ordered him to pay a \$400 deferred adjudication fee (rate: \$40 per month), \$277 for court costs (rate: \$40 per month), \$400 for court-appointed counsel (rate: \$35 per month), and \$100 to the Waco Family Abuse Center.
- 5. Effective January 29, 2016, the court discharged Randle from community supervision and dismissed the charges pending against him.

Case no. 2016-1543-C1--Assault Family Violence with a Prior

- 6. On or about October 31, 2017, in case no. 2016-1543-C1, in the 19th Judicial District Court of McClennan County, Texas, Randle pleaded guilty to third-degree felony Assault Family Violence with a Prior. He applied for community supervision probation.
- 7. On or about December 27, 2017, the court sentenced Randle to five years deferred adjudication probation and ordered him to serve 60 days in jail. His costs included: a \$750 fine (rate: \$15 per month), a \$450 BIPP fee, \$60 per month for supervision, \$65 (rate: \$5 per month) for pre-sentence investigation costs, and a \$25 Crimestoppers, Inc. fee. Once released from jail, the court ordered him to complete 300 hours community service, repeat BIPP, and comply with other conditions of supervision.
- 8. On or about August 23, 2018, the court issued an Order Amending Conditions of Deferred Adjudication, which required Randle to attend an Outpatient Substance Abuse Group Counseling Program and weekly Alcoholics Anonymous/Narcotics Anonymous meetings.

- 9. On or about October 15, 2018, the district attorney filed a Motion to Adjudicate Guilt because Randle violated the conditions of his probation by consuming marijuana, resisting and evading arrest, and failing to pay various court-ordered fines and fees.
- 10. On or about February 4, 2019, the court filed a Withdrawal of Motion to Adjudicate Guilt and issued an Order Amending Conditions of Deferred Adjudication. The court extended Randle's probation by three years starting December 26, 2022, and ordered him to be evaluated by a McClennan County behavioral health center and, if accepted, supervised within the county's mental health caseload.
- 11. On or about October 10, 2019, the court issued an order amending conditions of deferred adjudication. The court ordered that all costs Randle incurred since the date of his sentencing be paid to the district clerk of McLennan County through the McLennan County Community Supervision and Corrections Department at the rate of \$25 per month beginning 30 days from the order date.
- 12. Randle remains on probation until approximately December 26, 2025. To date, he has not paid any of his court costs.
- 13. The administrative law judge in a prior TDI contested case¹ held that second-degree felony aggravated assault constitutes fraudulent and dishonest conduct when: "[c]hoosing to put others at risk—either by driving while intoxicated or actually assaulting another person—is inherently 'untrustworthy' and dishonest.'"

Legal Allegations

- 1. Randle engaged in fraudulent or dishonest acts or practices, as contemplated by Tex. Ins. Code § 4005.101(b)(5), 28 Tex. Admin. Code § 1.502(e)(1), and prior SOAH decisions.
- 2. Randle committed offenses against the person as contemplated by Tex. Occ. CODE § 53.025 and 28 Tex. ADMIN. CODE § 1.502(e)(4)(B).
- 3. Under Tex. Occ. Code § 53.025 and 28 Tex. Admin. Code § 1.502(e)(4)(B), Randle committed third-degree felony assault, an offense of such a serious nature: as

described by Penal Code Chapter 22, that TDI considers it of prime importance in determining fitness for licensure.

- 4. TDI guidelines and 28 Tex. ADMIN. CODE § 1.502(c)-(e), emphasize that TDI:
 - a. considers it very important that applicants be honest, trustworthy, and reliable;
 - b. may refuse to issue an original license if the department determines that the applicant has committed a felony or has engaged in fraudulent or dishonest activity that directly relates to the duties and responsibilities of the licensed occupation; and
 - c. considers the offense of felony assault to be of such a serious nature that it is of prime importance when determining fitness for licensure, as contemplated in 28 Tex. Admin. Code § 1.502(e)(4)(B).

If one or more of the above allegations is found to be true, TDI asks the ALJ to enter a Proposal for Decision recommending that the Commissioner of Insurance issue an order:

- 1. denying Randle's license application and
- 2. granting any other just and appropriate relief to which the TDI may be entitled to by law.
