General remarks and official action taken:

This is a default order taken against Jose Manuel Rodriguez Jr (Respondent) because he submitted fraudulent withdrawal request forms on life insurance policies without the authorization of the policyholders. Respondent did not respond to a Notice of Hearing filed by the Texas Department of Insurance (TDI). This order revokes Respondent's license.

The following findings of fact and conclusions of law are adopted:

Findings of Fact

Failure to Respond to Notice of Hearing

- 1. On September 12, 2023, TDI filed a Notice of Hearing, attached as Exhibit A, and an Original Petition, attached as Exhibit B, with the State Office of Administrative Hearings.
- 2. TDI's factual allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order as findings of fact.
- 3. TDI sent the Notice of Hearing and Original Petition to Respondent's last known address provided in writing to the department, Redlands,

CA 92373. The Notice of Hearing and Original Petition were also sent by electronic mail.

4. Respondent failed to file a written response to the Notice of Hearing within 20 days of the date the Notice of Hearing and Original Petition were mailed.

Conclusions of Law

- 1. The commissioner has jurisdiction under Texas law, including TEX. INS. CODE §§ 82.051-82.055, 4001.002, 4001.102, 4001.105, 4005.101-4005.105, 4054.201 and 4101.051; TEX. OCC. CODE §§ 53.021-53.023; 28 TEX. ADMIN. CODE § 1.502; and TEX. GOV'T CODE §§ 2001.051-2001.178.
- 2. The commissioner has authority to dispose of this case informally under TEX. GOV'T CODE § 2001.056; TEX. INS. CODE § 82.055; and 28 TEX. ADMIN. CODE §§ 1.47, 1.88, and 1.89.
- 3. TDI provided proper notice of the hearing under TEX. GOV'T CODE §§ 2001.051, 2001.052, and 2001.054; and 28 TEX. ADMIN. CODE §§ 1.28, 1.88, 1.89, and 19.906.
- 4. Based on Respondent's failure to file a written response to the Notice of Hearing, TDI is entitled to disposition by default under 28 TEX. ADMIN. CODE §§ 1.88 and 1.89.
- 5. TDI's factual and legal allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order and deemed admitted as true under 28 TEX. ADMIN. CODE § 1.89.





ORIGINAL PETITION

The Texas Department of Insurance (TDI) seeks to take disciplinary action against Jose Manuel Rodriguez Jr. In support of this petition, TDI makes the following allegations upon information and belief:

Jurisdiction

The commissioner of insurance has jurisdiction over this matter under TEX. INS. CODE §§ 82.051-82.055, 4001.002, 4005.101, 4005.102, and 4054.201; and TEX. GOV'T CODE §§ 2001.051-2001.178.

Factual Allegations

- 1. Jose Manuel Rodriguez Jr (Rodriguez) holds a life agent license issued by TDI on April 4, 2016.
- 2. Between November 1, 2022, and December 30, 2022, Rodriguez submitted five fraudulent withdrawal request forms without the authorization of the policyholders to the Life Insurance Company of the Southwest.
- 3. Rodriguez submitted the withdrawal request forms to the Life Insurance Company of the Southwest with forged and unauthorized signatures.
- 4. Rodriguez altered checks for three bank accounts intended to receive the disbursed funds from the policy withdrawals.

FILED 454-24-00637 9/11/2023 9:39 AM STATE OFFICE OF ADMINISTRATIVE HEARINGS Carol Hale, CLERK 5. TDI sent a request for information to Rodriguez on March 16, 2023, pursuant to TEX. INS. CODE § 38.001, and Rodriguez failed to respond in writing not later than the 15th day after the date the inquiry was received.

Legal Allegations

- 1. Rodriguez has willfully violated an insurance law of this state, as contemplated in TEX. INS. CODE § 4005.101(b)(1).
- 2. Rodriguez engaged in fraudulent or dishonest acts or practices, as contemplated by TEX. INS. CODE § 4005.101(b)(4).
- 3. Rodriguez violated TEX. INS. CODE § 38.001 by failing to respond to a department inquiry in writing no later than the 15th day after the date the inquiry was received.

Relief Sought

If one or more of the above allegations is found to be true, TDI asks the Administrative Law Judge to enter a Proposal for Decision recommending that the commissioner of insurance issue an order:

- 1. revoking Rodriguez's license and
- 2. imposing any other just and appropriate relief to which the department may be entitled to by law, including any combination of the above actions.


