General remarks and official action taken:

This is a default order taken against Geoffrey Scott Sapenter & Angel Oak Investments, LLC (Respondents) because Geoffrey Scott Sapenter operated Angel Oak Investments, LLC without a license and issued fraudulent insurance policy documents. Respondents did not respond to a Notice of Hearing filed by the Texas Department of Insurance. This order revokes Respondents' licenses.

The following findings of fact and conclusions of law are adopted:

Findings of Fact

Failure to Respond to Notice of Hearing

- 1. On September 5, 2023, the department filed a Notice of Hearing, attached as Exhibit A, and an Original Petition, attached as Exhibit B, with the State Office of Administrative Hearings.
- 2. The department's factual allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order as findings of fact.

- 3. The department sent the Notice of Hearing and Original Petition to Respondents' last known address provided in writing to the department, Texas 77494. The Notice of Hearing and Original Petition were also sent by electronic mail and to an additional address associated with Respondents: P.O. Box 2882, Pflugerville, Texas 78691-2882.
- 4. Respondents failed to file a written response to the Notice of Hearing within 20 days of the date the Notice of Hearing and Original Petition were mailed.

Conclusions of Law

- 1. The commissioner has jurisdiction under Texas law, including Tex. Ins. Code §§ 81.001(b), 82.051-82.055, 84.021-84.044, 101.102, 4001.002, 4005.101, 4005.102, 4005.107, 4051.051, and 4054.051, and Tex. Gov't Code §§ 2001.051-2001.178.
- 2. The commissioner has authority to dispose of this case informally under Tex. Gov'T CODE § 2001.056; Tex. Ins. CODE § 82.055; and 28 Tex. ADMIN. CODE §§ 1.47, 1.88, and 1.89.
- 3. The department provided proper notice of the hearing under Tex. Gov't Code §§ 2001.051, 2001.052, and 2001.054, and 28 Tex. Admin. Code §§ 1.28, 1.88, 1.89, and 19.906.
- 4. Based on Respondents' failure to file a written response to the Notice of Hearing, the department is entitled to disposition by default under 28 Tex. ADMIN. CODE §§ 1.88 and 1.89.
- 5. The department's factual and legal allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order and deemed admitted as true under 28 Tex. ADMIN. CODE § 1.89.

ORIGINAL PETITION

The Texas Department of Insurance seeks to take disciplinary action against Geoffrey Scott Sapenter (Sapenter) and Angel Oak Investments, LLC. In support of this petition, the department makes the following allegations upon information and belief:

Jurisdiction

The Commissioner of Insurance has jurisdiction over this matter under Tex. INS. CODE §§ 81.001(b), 82.051-82.055, 84.021-84.044, 101.102, 4001.002, 4005.101, 4005.102, 4005.107, 4051.051, and 4054.051, and Tex. Gov't Code §§ 2001.051-2001.178.

Factual Allegations

<u>Licensure</u>

- 1. Sapenter, individual identification number 958600, holds a general lines agent license with a property and casualty qualification issued on August 11, 2011, and a life, accident, and health qualification issued on December 9, 2011.
- 2. Sapenter was appointed by Foremost County Mutual Insurance Company (Foremost) from June 15, 2017, to August 4, 2020, when the company canceled his appointment.
- 3. Sapenter is the designated responsible licensed person for Angel Oak Investments, LLC, firm identification number 170123. Angel Oak Investments, LLC was a general

lines agency with property and casualty, and life, accident, and health qualifications licensed on September 10, 2020, until September 10, 2022, when the license expired due to failure to renew.

<u>Unlicensed Insurance Agency</u>

- 4. Sapenter filed a certificate of formation for Angel Oak Investments, LLC, with the Texas Secretary of State, effective March 22, 2017. The company is still active.
- 5. Sapenter filed an assumed name filing with the Texas Secretary of State on January 29, 2020, listing "Angel Oak Insurance" as an assumed name for Angel Oak Investments, LLC. Angel Oak Insurance has never been licensed by the department or filed as an assumed name with the department.
- 6. During the department's investigation, Sapenter stated he was running an insurance agency. He confirmed that he employed licensed agents prior to, during, and after December 2019, the month in which the below described conduct occurred. Sapenter did not have an agency license until September 10, 2020. Prior to this date, Sapenter was operating an unlicensed insurance agency.

Fraudulent and Dishonest Conduct

C.D.

- 7. On December 28, 2019, C.D. purchased a vehicle from a car lot and insurance through Sapenter.
- 8. C.D. requested both comprehensive and collision coverage. She received a declaration page from Sapenter that same day. This declaration page listed her insurer as Bristol West Insurance Group, underwritten by Foremost, listed Sapenter and his Foremost producer code, included both coverages, and listed her policy premium total at \$1,065.
- 9. On February 4, 2020, C.D. suffered a loss and filed a claim with her insurer. It was at this time that C.D. became aware she did not have the coverage she purchased.

- 10. Foremost provided C.D. her actual declaration page. The policy she purchased on December 28, 2019, included comprehensive coverage, but not collision, and listed her policy premium total at \$716.
- 11. Foremost completed C.D.'s collision claim on March 17, 2020, with a payment of \$9,220.25. Foremost successfully pursued an errors and omissions claim against Sapenter and received payment from his carrier for this loss.

T.G. and V.G.

- 12. On December 28, 2019, T.G. and V.G., husband and wife, purchased two vehicles from a car lot and purchased the insurance for both through Sapenter.
- 13. They were emailed a policy ID card that day from info@angeloakinvests.com. This is the same email address given to the department by Sapenter when he obtained an agency license for Angel Oak Investments, LLC, in September 2020.
- 14. The policy ID card emailed to T.G. and V.G. on December 28, 2019, listed Angel Oak Insurance as the agent, Home State County Mutual Insurance Company, a subsidiary of Foremost, as the insurer, and listed the policy number as G00-4797238-00.
- 15. Between January 15, 2020, and January 18, 2020, T.G. and V.G. suffered a loss with one of the newly purchased vehicles.
- 16. On April 3, 2020, a complaint was filed with the department alleging that T.G. and V.G. purchased insurance through Sapenter and were emailed a policy ID card listing the effective coverage date as December 28, 2019, but the insurer could not locate a valid policy.
- 17. Foremost's investigation revealed that while T.G. and V.G. received a policy ID card, no policy was issued to them in December 2019. Additionally, the policy number was not in sequence with other policies issued at that time and had never been a valid policy number at any time.

- 18. However, Foremost was able to locate a policy for T.G. and V.G. under a different policy number. This policy was uploaded to Foremost's system on January 20, 2020, at 3:13 a.m. CT. This policy was not in force on the date of loss.
- 19. Foremost denied coverage for the reported loss prior to the effective policy date of January 20, 2020.

Legal Allegations

- 1. Sapenter willfully violated an insurance law of this state, as contemplated by Tex. INS. CODE § 4005.101(b)(1).
- 2. Sapenter misappropriated, converted to his own use, or illegally withheld money belonging to an insured, insurer, or beneficiary, in violation of Tex. INS. CODE § 4005.101(b)(4).
- 3. Sapenter engaged in fraudulent or dishonest acts or practices, in violation of Tex. INS. CODE § 4005.101(b)(5).
- 4. Sapenter engaged in acts constituting the business of insurance without a license, as defined in Tex. Ins. Code § 101.051, in violation of Tex. Ins. Code §§ 101.102, 4001.101, 4051.051, 4054.051, and 28 Tex. Admin. Code § 19.902.
- 5. Sapenter failed to register an assumed name by filing with the department a completed LDTL form together with the required fee, in violation of 28 TEX. ADMIN. CODE § 19.902(c).

Relief Sought

If one or more of the above allegations is found to be true, the department asks the Administrative Law Judge to enter a Proposal for Decision recommending that the Commissioner of Insurance issue an order:

- 1. revoking Geoffrey Scott Sapenter's licenses;
- 2. directing Geoffrey Scott Sapenter to pay an administrative penalty under Tex. INS. CODE §§ 84.021 84.022;
- 3. directing Geoffrey Scott Sapenter to make restitution to victim under Tex. INS. CODE § 82.053;

- 4. ordering Geoffrey Scott Sapenter to cease and desist from engaging in the business of insurance through any unauthorized entity, including Angel Oak Investments, LLC; and
- 5. imposing any other just and appropriate relief to which the department may be entitled to by law, including any combination of the above actions.
