General remarks and official action taken:

This is a default order taken against Luis F Barbaresco Garcia (Respondent) because he submitted applications for life insurance policies with invalid personal identifiable information which were paid for with his bank account. Respondent did not respond to a Notice of Hearing filed by the Texas Department of Insurance (TDI). This order revokes Respondent's license.

The following findings of fact and conclusions of law are adopted:

Findings of Fact

Failure to Respond to Notice of Hearing

- On October 23, 2023, TDI filed a Notice of Hearing, attached as Exhibit A, together with an Original Petition, attached as Exhibit B, with the State Office of Administrative Hearings.
- 2. TDI's factual allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order as findings of fact.

- 3. TDI sent the Notice of Hearing and Original Petition together to Respondent's last known address provided in writing to TDI, Lewisville, Texas 75067. The Notice of Hearing and Original Petition were also sent by electronic mail.
- 4. Respondent failed to file a written response to the Notice of Hearing within 20 days of the date the Notice of Hearing and Original Petition were mailed.

Conclusions of Law

- 1. The commissioner has jurisdiction under Texas law, including Tex. Ins. Code §§ 82.051-82.055, 4001.002, 4001.102, 4001.105, 4005.101-4005.105, 4054.051, and 4101.051; Tex. Occ. Code §§ 53.021-53.023; 28 Tex. Admin. Code § 1.502; and Tex. Gov't Code §§ 2001.051-2001.178.
- 2. The commissioner has authority to dispose of this case informally under Tex. GOV'T CODE § 2001.056; Tex. Ins. Code § 82.055; and 28 Tex. Admin. Code §§ 1.47, 1.88, and 1.89.
- 3. TDI provided proper notice of the hearing under Tex. Gov't Code §§ 2001.051, 2001.052, and 2001.054; and 28 Tex. ADMIN. Code §§ 1.28, 1.88, 1.89, and 19.906.
- 4. Based on Respondent's failure to file a written response to the Notice of Hearing, TDI is entitled to disposition by default under 28 Tex. ADMIN. CODE §§ 1.88 and 1.89.
- 5. TDI's factual and legal allegations set out in the attached Notice of Hearing and Original Petition are incorporated in this order and deemed admitted as true under 28 Tex. Admin. Code § 1.89.



ORIGINAL PETITION

The Texas Department of Insurance (TDI) seeks to take disciplinary action against Luis F Barbaresco Garcia. In support of this petition, TDI makes the following allegations upon information and belief:

Jurisdiction

The commissioner of insurance has jurisdiction over this matter under Tex. INS. CODE §§ 82.051-82.055, 4001.002, 4005.101, 4005.102, and 4054.051; and Tex. Gov't Code §§ 2001.051-2001.178.

Factual Allegations

- 1. Luis F Barbaresco Garcia (Garcia) holds a general lines agent license with life, accident, health, and HMO qualification issued by TDI on October 29, 2021.
- 2. Between December 6, 2022, and January 4, 2023, Garcia submitted seven applications to John Hancock Life Insurance Company for term policies which resulted in policies being issued on five individuals.
- 3. Garcia entered invalid personal identifiable information on three of the insured individuals.
- 4. All five of the policies issued were paid for by a bank account owned by Garcia.

- 5. Garcia received \$11,992.42 in commissions for the above issued policies and has a remaining commission debt balance of \$2,910.58 owed to John Hancock Life Insurance Company.
- 6. Garcia failed to timely respond to a request for information sent by TDI pursuant to Tex. Ins. Code § 38.001 on March 21, 2023.

Legal Allegations

- 1. Garcia has willfully violated an insurance law of this state, as contemplated in Tex. INS. Code § 4005.101(b)(1).
- 2. Garcia has engaged in fraudulent or dishonest acts or practices, as contemplated by Tex. Ins. Code § 4005.101(b)(5).
- 3. Garcia violated Tex. Ins. Code § 38.001 by failing to respond to a TDI inquiry in writing not later than the 15th day after the date the inquiry was received.

Relief Sought

If one or more of the above allegations is found to be true, TDI asks the Administrative Law Judge to enter a Proposal for Decision recommending that the commissioner of insurance issue an order:

- 1. revoking Luis F Barbaresco Garcia's license, and
- 2. imposing any other just and appropriate relief to which the department may be entitled to by law, including any combination of the above actions.
