Requestor's Position

Amount in Dispute: \$252.35

Respondent's Position

"The provider filed a DWC60, seeking Medical Fee Dispute Resolution for a date of service of July 11, 2023. The provider billed 16 units for a Functional Capacity Evaluation. The bill was in the amount of \$1,014.88. The provider acknowledges that the carrier had already reimbursed him the amount of \$762.53. The provider is seeking an additional payment of \$252.35... Compare that to the carrier's calculation of the reimbursement which the care has specifically explained in its calculation of how that reimbursement amount was determined. The first unit of the 16 units is paid at \$63.53 whereas subsequent units are paid at \$46.60. The total the provider is entitled to is \$762.53. That is the amount the provider has already been paid. The provider is not entitled to any additional payment."

Findings and Decision

Authority

This medical fee dispute is decided according to Texas Labor Code §413.031 and applicable rules of the Texas Department of Insurance, Division of Workers' Compensation (DWC).

Statutes and Rules

1. 28 Texas Administrative Code (TAC) §133.307 sets out the procedures for resolving medical fee disputes.
2. 28 TAC §134.203 sets out the fee guideline for professional medical services.
3. 28 TAC §134.210 applied to fee guidelines for division-specific services.
4. 28 TAC §134.225 sets the reimbursement guidelines for FCEs.

Denial Reasons

The insurance carrier reduced or denied the payment for the disputed services with the following claim adjustment codes:

- 197 -
- 1002 – Due to an error in processing the original bill, we are recommending further payment be made for the above noted procedure.
- 2008 – Additional payment made on appeal/reconsideration.
- 119- Benefit maximum for this time period or occurrence has been reached.
- P12 – Workers' Compensation Jurisdictional fee schedule adjustment.
- W3 – Bill is a reconsideration or appeal.
- 163 – The charge for this procedure exceeds the unit value and/or the multiple procedure rules.

Issues

1. Is CHRISTOPHER HENN DC entitled to additional reimbursement?

Findings

1. CHRISTOPHER HENN DC is seeking additional reimbursement for a functional capacity evaluation performed on July 11, 2023. The examination is identified as a division-specific service with billing code 97750-FC.

28 TAC §134.225 states: "The following applies to functional capacity evaluations (FCEs) ... FCEs shall be billed using CPT code 97750 with modifier 'FC.' FCEs shall be reimbursed in accordance with §134.203(c)(1) of this title."

Per 28 TAC §134.203 (b)(1), parties are required to apply Medicare payment policies, including its coding, billing, correct coding initiatives (CCI) edits, modifiers, and other payment policies in effect on the date a service is provided with any additions or exceptions in the rules to workers' compensation coding, billing, reporting, and reimbursement of professional medical services.

28 TAC §§134.203 (a)(7) and 134.210 (a) state that specific provisions contained in the Texas Labor Code or division rules shall take precedence over any conflicting provision adopted or utilized by CMS in administering the Medicare program. However, no such conflict regarding billing or reimbursement was found that applies to a division-specific functional capacity evaluation. Therefore, Medicare reimbursement rules are applied to the examination in question.

Per [Medicare Claims Processing Manual \(cms.gov\)](#), Chapter 5, 10.7, effective February 6, 2019:

Medicare applies a multiple procedure payment reduction (MPPR) to the practice expense (PE) payment of select therapy services. The reduction applies to the HCPCS codes contained on the list of "always therapy" services ...

Many therapy services are time-based codes, i.e., multiple units may be billed for a single procedure ...

Full payment is made for the unit or procedure with the highest PE payment ... For subsequent units and procedures with dates of service on or after April 1, 2013, furnished to the same patient on the same day, full payment is made for work and malpractice and 50 percent payment is made for the PE for services submitted on either professional or institutional claims.

Procedure code 97750-FC is classified as "always therapy" in the 2023 Therapy Code List and Dispositions found in the [Annual Therapy Update | CMS](#) and has a value of "5" on the MFSD. Therefore, the MPPR applies to the reimbursement of this code.

On the disputed date of service, the requestor billed CPT code 97750-FC x 16 units.

As described above, the multiple procedure discounting rule applies to the disputed service.

The MPPR Rate File that contains the payments for 2023 services is found at <https://www.cms.gov/Medicare/Billing/TherapyServices/index.html>

To determine the MAR the following formula is used:

$(\text{DWC Conversion Factor} / \text{Medicare Conversion Factor}) \times \text{Medicare Payment} = \text{MAR}$.

- MPPR rates are published by carrier and locality.
- The disputed date of service is July 11, 2023.
- The disputed service was rendered in zip code 78550, locality 99.
- The Medicare participating amount for CPT code 97750-FC at this locality is \$33.21 for the first unit, and \$24.36 for subsequent 15 units.
- The 2023 DWC Conversion Factor is 64.83
- The 2023 Medicare Conversion Factor is 33.8872.
- The MAR amount for CPT code 97750-FC at this locality is \$63.53 for the first unit, and \$699.05 for the subsequent 15 units.
- Using the above formula, the DWC finds the total MAR is \$762.58.
- The respondent paid \$762.53
- No additional reimbursement is recommended.

The division finds that the requestor has not established that additional reimbursement is due.

Conclusion

The outcome of this medical fee dispute is based on the evidence presented by the requestor and the respondent at the time of adjudication. Though all evidence may not have been discussed, it was considered.

The division finds that no additional reimbursement is due.

Order

Under Texas Labor Code §§413.031 and 413.019, DWC has determined the requestor is entitled to \$0.00 additional reimbursement for the disputed service.

A party seeking review must submit DWC Form-045M, *Request to Schedule, Reschedule, or Cancel a Benefit Review Conference to Appeal a Medical Fee Dispute Decision (BRC-MFD)* and follow the instructions on the form. You can find the form at www.tdi.texas.gov/forms/form20numeric.html. DWC must receive the request within **20 days** of when you receive this decision. You may fax, mail, or personally deliver your request to DWC using the contact information on the form or the field office handling the claim.
