Findings and Decision

Authority

This medical fee dispute is decided according to Texas Labor Code Section [413.031](#) and other applicable laws and rules of the Texas Department of Insurance, Division of Workers' Compensation (DWC).

Statutes and Rules

1. 28 Texas Administrative Code (TAC) Section [133.307](#) sets out the procedures for resolving medical fee disputes.
2. 28 TAC Section [134.203](#) sets out the fee guidelines for professional medical services.

Adjustment Reasons

The insurance carrier denied payment for the disputed services with the following reasons:

- 193 – Original payment decision is being maintained. Upon review, it was determined that this claim was processed properly.
- N600 – Adjusted based on the applicable fee schedule for the region in which the service was rendered.
- P12 – Workers' compensation jurisdictional fee schedule adjustment.
- 309 – The charge for this procedure exceeds the fee schedule allowance.
- 18 – Exact duplicate claim/service.

Issues

1. What is DWC considering in this medical fee dispute?

2. What rule is applicable to reimbursement?
3. Has DWC determined whether additional reimbursement is due?

Findings

1. The requester seeks additional reimbursement in the amount of \$273.62 for professional medical services rendered on February 3, 2026.
2. Review of the submitted medical bill indicates the following codes were submitted 96116, 96121-59, 96133-59, 96136-59, 96137-59, 96138-59 and 96139-59. The requester has indicated the amount paid is not in accordance with applicable fee guideline. The applicable fee guideline and calculation is as follows.

28 TAC Section 134.203 (c) (1)(2) states in pertinent part,

- c. To determine the Maximum Allowable Reimbursement (MAR) for professional services, system participants shall apply the Medicare payment policies with minimal modifications.
 1. For service categories of Evaluation & Management, General Medicine, Physical Medicine and Rehabilitation, Radiology, Pathology, Anesthesia, and Surgery when performed in an office setting, the established conversion factor to be applied is \$52.83...
 2. The conversion factors listed in paragraph (1) of this subsection shall be the conversion factors for calendar year 2008. Subsequent year's conversion factors shall be determined by applying the annual percentage adjustment of the Medicare Economic Index (MEI) to the previous year's conversion factors, and shall be effective January 1st of the new calendar year...

To determine the MAR the following formula is used:

$(\text{DWC Conversion Factor} / \text{Medicare Conversion Factor}) \times \text{Medicare Payment} = \text{MAR}.$

- The CMS physician fee schedule rates are published by carrier and locality.
- Disputed service was rendered in zip code 78228, locality 04412 99, Rest of Texas (San Antonio).
- The disputed date of service is February 3, 2026.
- The 2026 DWC Conversion Factor is 72.07.
- The 2026 Medicare Conversion Factor is 33.4009.
- $90791 - 72.07 / 33.4009 \times \$92.46 = \$199.50$. Carrier paid \$199.50. No additional payment due.

- 96121 – 72.07/33.4009 x \$74.53 = \$160.82 x 3 = \$482.45. Carrier paid \$482.46. No additional payment due.
- 96132 – 72.07/33.4009 x \$120.27 = \$259.51. Carrier paid \$259.51. No additional payment due.
- 96133 – 72.07/33.4009 x \$96.18 = \$207.53 x 7 = \$1,452.71. Carrier paid \$1,452.71. No additional payment due.
- 96136 – 72.07/33.4009 x \$42.43 = \$91.55. Carrier paid \$91.55. No additional payment due.
- 96137 – 72.07/33.4009 x \$35.97 = \$77.61 x 11 = \$853.75. Carrier paid \$853.71. No additional payment due.
- 96138 – 72.07/33.4009 x \$35.80 = \$77.25. Carrier paid \$77.25. No additional payment due.
- 96139 – 72.07/33.4009 x \$33.60 x 33.60 = \$72.50 x 11 = \$797.50. Carrier paid \$797.50. No additional payment due.

3. Based on the available information at the time of this review, DWC finds the payment made by the insurance carrier was at MAR. No additional payment is recommended.

Conclusion

The outcome of this medical fee dispute is based on the evidence the requester and the respondent presented at the time of adjudication. Though all evidence may not have been discussed, it was considered.

DWC finds the requester has not established that additional reimbursement is due.

Order

Under Texas Labor Code Sections [413.031](#) and [413.019](#), DWC has determined the requester is entitled to \$0.00 additional reimbursement for the disputed services.
