1, 2, 3, 4	Yes	These products satisfy TDI's criteria for protection from windborne debris in the Inland I and Seaward zone. Install the assemblies at a height on the structure that does not exceed the design pressure rating for the assemblies.	

Installation:

System 1: The wall framing must be minimum Southern Yellow Pine dimension lumber. The window assembly must be secured to the wall framing using the integral aluminum nailing fin with minimum No. 8 PPH SS screws. The fasteners are located approximately 1" to 3" from each corner and 7" to 8" on center along the perimeter of the window. All fasteners must be long enough to penetrate a minimum of 1-1/2" into the wall framing.

System 2: The wall framing must be minimum Southern Yellow Pine dimension lumber. The window assembly must be secured to the wall framing using the frame of the window with minimum No. 10 x 3" PFH SS screws. The fasteners are located approximately 6" from each corner and 15" to 21" on center along the perimeter of the window. All fasteners must be long enough to penetrate a minimum of 1-1/2" into the wall framing.

System 3: The wall framing must be minimum Southern Yellow Pine dimension lumber. The window assembly must be secured to the wall framing using the frame of the window with minimum No. 10 x 3" PFH SS screws. The fasteners are located approximately 6" from each corner and 15" to 17" on center along the perimeter of the window. All fasteners must be long enough to penetrate a minimum of 1-1/2" into the wall framing.

System 4: The wall framing must be minimum Southern Yellow Pine dimension lumber. The window assembly must be secured to the wall framing using the integral aluminum nailing flange with minimum No. 8 PPH SS screws. The fasteners are located approximately 2" to 3" from each corner and 7" to 8" on center along the perimeter of the window. In addition, the assembly is secure to the wall framing with masonry clips (5.00" x 1-1/2" x 20-gauge galvanized steel). One clip is required approximately 3" and 6" on each side of the mull jamb at the head and the sill. The clip is secured to wall framing with two (2) No. 8 PPH SS screws. The clip is secured to the window frame with three (3) No. 7 x 5/8" PH screws. All fasteners must be long enough to penetrate a minimum of 1-1/2" into the wall framing.

Note: Keep the manufacturer's installation instructions available on the job site during installation. Use corrosion resistant fasteners as specified in the IRC, the IBC, and the Texas Revisions.
