1-3	Yes	These products satisfy TDI's criteria for protection from windborne debris. Install the assemblies at a height on the structure that does not exceed the design pressure rating for the assemblies.

Installation (One of the Following):

Option 1: The wood wall framing members must be minimum Spruce-Pine-Fir dimension lumber. The window assembly is secured to the wall framing using a nailing fin. The nailing fin is secured to the wall framing with 1-1/2" long, minimum 12-gauge, smooth shank roofing nails. Locate the nails approximately 4" from each corner and 10-1/2" on center along the perimeter. In addition, use 24-gauge steel installation clips (1-1/2" x 9" x 0.024) located 4" from each corner and 6" on center. Secure the clips to the window frame with three (3) No. 8 x 3/4" screws and to the wall framing with two (2) No. 10 x 1-1/2" screws. Fasteners must be long enough to penetrate a minimum of 1-1/2" into the wall framing members.

Option 2: The wood wall framing members must be minimum Spruce-Pine-Fir dimension lumber. The window assembly is secured to the wall framing with No. 12 x 2-1/2" screws. Locate the screws approximately 3" from each corner and 6" on center. Fasteners must be long enough to penetrate a minimum of 1-1/2" into the wall framing members.

Note: Keep the manufacturer's installation instructions available on the job site during installation. Use corrosion resistant fasteners as specified in the IRC and the IBC.
